Typically, deposit collections are located in schools for the blind, nursing homes, hospitals, and rehabilitation centers. Public or private schools may also apply to hold deposit collections; however, the students in public or

private schools must be certified as eligible on an individual basis and must be the direct and only recipients of the materials and equipment.
