RE: Confirmation Notice

The Missouri Secretary of State is committed to ensuring election integrity by verifying that only U.S. citizens are voting in Missouri. This involves reviewing voter registration records using data from the Missouri Department of Revenue and the U.S. Department of Homeland Security's SAVE program.

At this time, we have been unable to verify your citizenship. We acknowledge that these databases may not reflect recent changes in citizenship status, and mismatches can occur. **Receipt of this letter does not mean we have determined you are ineligible to vote.**

To verify your U.S. citizenship, please submit proof of U.S. citizenship or the enclosed signed affirmation form **directly to your local election authority within 90 days of receipt of this letter.**

Your local election authority's contact information is provided below. The local election authority is responsible for reviewing your submission and maintaining your voter registration record.

YOUR RIGHT TO CORRECT FEDERAL RECORDS

If you believe your citizenship or immigration status is not accurately reflected in federal records, you have the right to contact U.S. Citizenship and Immigration Services (USCIS) directly to request a correction of your records prior to any final decision regarding your voter registration. USCIS can be reached at www.uscis.gov or (800) 375-5283.

YOUR RIGHT TO APPEAL

If any action is taken regarding your voter registration based on information from this review, you have the right to notice, a hearing before your local election authority, and any other due process available under Missouri and federal law, including the National Voter Registration Act and the Help America Vote Act. Contact your local election authority or this office for information about your rights.

IF YOU DO NOT RESPOND

Failure to respond by the deadline will result in your registration information and the results of this review being referred to your local election authority for action in accordance with Missouri and federal law. Your local election authority, not the Secretary of State's Office, is responsible for any final changes to your voter registration record.
