**ORDER**

On March 15, 2019, the Enforcement Section of the Securities Division of the Office of Secretary of State (“the Enforcement Section”), through Enforcement Counsel Hampton Williams, submitted a Petition for Order to Cease and Desist and Order to Show Cause why Civil Penalties Should not be Imposed (“the Petition”). On March 20, 2019, the Missouri Commissioner of Securities (“the Commissioner”) issued an Order to Cease and Desist and Order to Show Cause why Civil Penalties Should not be Imposed (“the C&D Order”).

On May 15, 2019, Respondents submitted a Motion to Dismiss. On May 21, 2019, the Enforcement Section submitted a Response to Respondents’ Motion to Dismiss. The Respondents filed a Reply on May 28, 2019, and the Enforcement Section filed a Sur-Reply on May 31, 2019. On May 28, 2019, the Enforcement Section filed a Motion for Default Judgment. On June 5, 2019, the Respondents filed a separate Motion to Dismiss for Lack of Jurisdiction. After considering the parties’ arguments, for good cause shown, the Commissioner **DENIES** the Enforcement Section’s Motion for Default Judgment. The Commissioner further rules that Respondents’ Motion to Dismiss for Lack of Jurisdiction is **GRANTED** and this action is dismissed without prejudice. The C&D Order is vacated. The Enforcement Section is granted leave to re-file a new Petition and proposed Order to Cease and Desist.
