EXECUTIVE ORDER 09-24

WHEREAS, patients throughout the State of Missouri receive exemplary medical care from Missouri hospitals and health care providers; and

WHEREAS, there are concerns that health insurance companies are not providing timely reimbursement to Missouri hospitals and health care providers for services provided to Missourians; and

WHEREAS, the failure of health insurance companies to make timely payments could significantly compromise the ability of Missouri hospitals and health care providers to provide quality medical care to Missourians; and

WHEREAS, the State of Missouri is committed to ensuring that Missouri hospitals and health care providers are promptly paid by health insurance companies for services provided and that Missourians continue to receive superior medical care.

NOW THEREFORE, I, JEREMIAH W. (JAY) NIXON, GOVERNOR OF THE STATE OF MISSOURI, by virtue of the authority vested in me by the constitution and laws of the State of Missouri do hereby create the Prompt Pay for a Healthy Missouri Project ("Project") to examine issues relating to the timely reimbursement of Missouri hospitals and health care providers by health insurance companies.


The Director of Insurance, Financial Institutions and Professional Registration is appointed Project Director and will have supervisory authority over all aspects of the Project. The Department of Insurance, Financial Institutions and Professional Registration will provide administrative support to the Project.

The Directors of other executive branch departments will provide assistance to this project as requested by the Project Director.

The Project Director shall issue a report to the Governor by December 31, 2009.

The Project will terminate on December 31, 2009 unless extended by subsequent Executive Order.

Proposed Rules

The notice of proposed rulemaking is required to contain an explanation of any new rule or any change in an existing rule and the reasons therefor. This is set out in the Purpose section with each rule. Also required is a citation to the legal authority to make rules. This appears following the text of the rule, after the word "Authority."

An important function of the *Missouri Register* is to solicit and encourage public participation in the rulemaking process. The law provides that for every proposed rule, amendment, or rescission there must be a notice that anyone may comment on the proposed action. This comment may take different forms.

f an agency is required by statute to hold a public hearing before making any new rules, then a Notice of Public Hearing will appear following the text of the rule. Hearing dates must be at least thirty (30) days after publication of the notice in the *Missouri Register*. If no hearing is planned or required, the agency must give a Notice to Submit Comments. This allows anyone to file statements in support of or in opposition to the proposed action with the agency within a specified time, no less than thirty (30) days after publication of the notice in the *Missouri Register*.

An agency may hold a public hearing on a rule even though not required by law to hold one. If an agency allows comments to be received following the hearing date, the close of comments date will be used as the beginning day in the ninety (90)-day-count necessary for the filing of the order of rulemaking.

f an agency decides to hold a public hearing after planning not to, it must withdraw the earlier notice and file a new notice of proposed rulemaking and schedule a hearing for a date not less than thirty (30) days from the date of publication of the new notice.

Title 7—DEPARTMENT OF TRANSPORTATION Division 10—Missouri Highways and Transportation Commission Chapter 27—David's Law Signing

PROPOSED RULE

7 CSR 10-27.010 Definitions

PURPOSE: This rule provides definitions of terms applicable to David's Law authorizing drunk driving victim memorial signs.

(1) Applicant—The person requesting the installation of a drunk driving victim memorial sign and who must be an immediate family member of the victim or have written consent from an immediate family member to submit the application on his/her behalf.

(2) Application-The document developed and posted on the depart-

ment's website for the sole purpose of gathering information from the applicant requesting a drunk driving victim memorial sign to determine if the request qualifies for a drunk driving victim memorial sign.

(3) Commission—The Missouri Highway and Transportation Commission.

(4) Department—The Missouri Department of Transportation.

(5) Immediate family member—A spouse, child, stepchild, brother, stepbrother, sister, stepsister, mother, stepmother, father, or stepfa-ther.

(6) Intoxicated—The person who was shown to have been operating a motor vehicle at the time of a motor vehicle accident and was either: 1) in violation of section 577.012 or 577.010, RSMo; or 2) was committing an intoxication-related traffic offense, as that term is defined in section 577.023.1(3), RSMo; or 3) less than twenty-one (21) years of age and determined to be operating a motor vehicle with two-hundredths of one-percent or more blood alcohol content; or 4) determined to be operating a commercial motor vehicle and either driving under the influence of alcohol or driving under the influence of a controlled substance, as these terms are defined in section 302.700, RSMo.

(7) MSHP—The Missouri State Highway Patrol.

(8) Sign—The drunk driving victim memorial sign.

(9) State highway—A route that is designated as an Interstate, US, Missouri numbered or Missouri lettered route, or any other roadway that is owned or maintained by the Missouri Highways and Transportation Commission.

AUTHORITY: section 227.295, CCS for SCS for HB 91, Ninety-fifth General Assembly, 2009. Original rule filed Sept. 3, 2009.

PUBLIC COST: This proposed rule will not cost state agencies or political subdivisions more than five hundred dollars (\$500) in the aggregate.

PRIVATE COST: This proposed rule will cost private entities approximately ninety thousand dollars (\$90,000) in the aggregate.

Title 7—DEPARTMENT OF TRANSPORTATION Division 10—Missouri Highways and Transportation Commission Chapter 27—David's Law Signing

PROPOSED RULE

7 CSR 10-27.020 Eligibility Requirements

PURPOSE: This rule provides eligibility requirements to obtain a drunk driving victim memorial sign under David's Law.

(1) A sign may only be installed in memory of an individual who died in Missouri as a result of a motor vehicle accident caused by a person who was shown to have been operating a motor vehicle at the time of the accident while intoxicated.

(2) A sign shall not be installed in memory of those who themselves were intoxicated while also operating a motor vehicle.

(3) Only one (1) sign may be requested and installed for a victim of a motor vehicle accident caused by a person who was shown to be operating a motor vehicle in an intoxicated condition at the time of the accident.

AUTHORITY: section 227.295, CCS for SCS for HB 91, Ninety-fifth General Assembly, 2009. Original rule filed Sept. 3, 2009.

PUBLIC COST: This proposed rule will not cost state agencies or political subdivisions more than five hundred dollars (\$500) in the aggregate.

PRIVATE COST: This proposed rule will cost private entities approximately ninety thousand dollars (\$90,000) in the aggregate.

NOTICE TO SUBMIT COMMENTS: Anyone may file a statement in support of or in opposition to this proposed rule with the Missouri Department of Transportation, Pam Harlan, Secretary to the Commission, PO Box 270, Jefferson City, MO 65102. PROPOSED RULE

7 CSR 10-27.030 Sign Design and Installation

PURPOSE: This rule provides the design and installation requirements for drunk driving victim memorial signs under David's Law.

(1) A sign shall only be installed on Missouri state highways.

(2) Only the commission has the authority to install drunk driving victim memorial signs on state highways. No other adornment, land-scaping, or modification of the sign or ground around the sign shall be permitted.

(3) The sign will be installed as close as possible to the location where the crash occurred, on the right side of the roadway, in the direction of travel on that roadway where the accident occurred.

(4) The placement of the sign shall not interfere with other signs, traffic control devices, or other safety devices.

(5) The sign will be installed with the sign face parallel to the lanes of the roadway in a location that will not increase the difficulty in maintaining the right of way, typically placed at the edge of the mowing boundary.

(6) The sign design will consist of a blue background with white legend. The sign will contain the following legend without variation:

- (A) "DRUNK DRIVING VICTIM";
- (B) First, middle, and last initials of the victim's name;

(C) Numbers representing the month and year the victim died; and (D) "THINK ABOUT IT."

(7) Any given sign will only contain information for one (1) victim; however, multiple signs may be installed on a given sign post at the discretion of the commission.

(8) The overall sign dimensions will be thirty inches wide by eighteen inches tall $(30" \times 18")$.

PROPOSED RULE

7 CSR 10-27.040 Administration

PURPOSE: This rule provides the procedure to administer David's Law authorizing drunk driving memorial signs.

(1) The commission will develop an application that will capture the information the applicant must submit to determine eligibility for a sign under 7 CSR 10-27.010–7 CSR 10-27.040. The commission will make the application readily available to the public in an easily accessible location, such as the commission's Internet site.

(2) Applicants must complete and submit an application to the commission. This application shall contain:

- (A) Name and contact information of the applicant;
- (B) The name of the victim;
- (C) Location of the crash-
 - 1. County;
 - 2. Route; and
 - 3. Direction;
- (D) Mile maker or distance from another state route;
- (E) Date of the crash; and

(F) Name of at least one (1) of the vehicle operators involved in the crash.

(3) The commission shall be responsible for reviewing applications. The commission will use the information in the application as well as the other documentation required by this rule to determine if the application can be approved. The commission reserves the right to request additional information from the applicant if the circumstances of the crash are not clear.

(4) The applicant will also be responsible for providing the official accident report for the crash. If there is no accident report or if the report does not include details on intoxication, additional documentation must also be provided that clearly indicates the intoxication of the driver and verifies that the victim was not intoxicated. Such additional documentation may include, but is not limited to, medical records of the intoxicated driver, autopsy report, a coroner report, or any other document.

(5) The applicant is also responsible for submitting the fee for the sign along with the application, made payable to Department of Revenue—Credit State Road Fund. If the application is not approved, the entire fee will be returned to the applicant.

(6) Each sign will remain in place for a period of ten (10) years during which time the commission will maintain the sign in the event of damage or theft. At the end of the ten (10)-year period the sign will be removed unless renewed as provided in this rule.

(7) If applicants wish to keep the sign in place for an additional ten (10) years, the applicant is responsible for notifying the commission one (1) year in advance of the expiration of the ten (10)-year period and for remitting to the commission a renewal fee for the subsequent ten (10)-year period.

(8) Once signs are removed, they will remain the property of the commission and the sign blanks will be reused to make new signs.

(9) The fee for the sign shall represent the commission's cost to administer the program, manufacture, install, and maintain the sign

for a period of ten (10) years. This cost, as well as the ten (10)-year renewal fee, will be based on the commission's operating costs for the year in which the original request or renewal request is received by the commission.

(10) All commission determinations under this rule, including but not limited to, approval or disapproval of applications, the amount of the sign fee, and all other determinations are final and not subject to appeal.

SUMMARY OF COMMENTS: A public hearing on this proposed amendment was held August 11, 2009, and the public comment period ended that same day. COMMENT #1: The Department of Health and Senior Services commented on new language in 1 CSR 20-6.010(2). They felt this language meant that if non-compliant, some action would follow. They recommended using language that did not say the agency would do something when, in reality, the enforcement is lax.

RESPONSE: The board considered the comment and decided to retain the proposed language.

COMMENT #2: The division staff suggested removing the current language in 1 CSR 20-6.010(8) regarding counting the core curriculum toward the sixteen (16)-hour and forty (40)-hour requirements. RESPONSE AND EXPLANATION OF CHANGE: The board considered the suggestion and decided to remove this language.

COMMENT #3: In order to follow the Equal Employment Opportunity Commission's recommendation with regard to the frequency of diversity and prevention of unlawful discrimination programs, the board considered a change to the proposed language in 1 CSR 20-6.010(8).

RESPONSE AND EXPLANATION OF CHANGE: The board considered the suggestion and decided to change the frequency to two (2) years but not to exceed three (3) years.

1 CSR 20-6.010 Management Training

(8) Incumbents in all positions covered in this rule are also required to take a Core Curriculum consisting of performance management, diversity, and prevention of unlawful discrimination. Diversity and prevention of unlawful discrimination programs shall be required of incumbents in all positions covered in this rule, and every effort shall be made to meet these requirements every two (2) years but not to exceed three (3) years. The format and time frames of these programs shall be determined by the departments. STAC will provide guidance to departments regarding the content of these programs as/when needed.

TIMELINE CALCULATOR

The Administrative Rules Division is pleased to announce that a new tool is available on the SOS Administrative Rules web page to assist in calculating critical rulemaking dates. A timeline calculator is now available at www.sos.mo.gov/adrules/datecalc/default.aspx.

To use the timeline calculator, select the type of rulemaking you are doing using the drop-down menu-

- Proposed rulemaking;
- Order of rulemaking;
- Emergency rulemaking; or
- First day to file order with AdRules.

Use the built-in calendar to select your filing date, or type in your filing date using the mm/dd/yy format.

For proposed rulemaking, if you are having a hearing or an extended comment period, you may check the override thirty-day comment box and insert the date for the final day to submit comments or the date of the hearing, whichever is later.

For orders of rulemaking, if you have an effective date that is not the normal thirty days after publication, please check the override effective date and insert the correct effective date.

For emergency rulemaking, there are two override boxes available. The first override box is used to select an effective date that is later than ten days after the emergency rulemaking is filed. The second override box is used to choose an expiration date that is less than the one hundred eighty days or thirty legislative days.

To calculate the first day an order(s) may be filed with SOS, select the drop-down menu, then use the calendar to select the date, or manually enter the date, the order(s) was filed with JCAR.
