HOW TO CITE RULES AND RSMo

RULES—Cite material in the *Missouri Register* by volume and page number, for example, Vol. 28, *Missouri Register*, page 27. The approved short form of citation is 28 MoReg 27.

The rules are codified in the *Code of State Regulations* in this system—

They are properly cited by using the full citation, i.e., 1 CSR 10-1.010.

Each department of state government is assigned a title. Each agency or division within the department is assigned a division number. The agency then groups its rules into general subject matter areas called chapters and specific areas called rules. Within a rule, the first breakdown is called a section and is designated as (1). Subsection is (A) with further breakdown into paragraph 1., subparagraph A., part (I), subpart (a), item I. and subitem a.

RSMo—The most recent version of the statute containing the section number and the date.

Rules appearing under this heading are filed under the authority granted by section 536.025, RSMo 2000. An emergency rule may be adopted by an agency if the agency finds that an immediate danger to the public health, safety, or welfare, or a compelling governmental interest requires emergency action; follows procedures best calculated to assure fairness to all interested persons and parties under the circumstances; follows procedures which comply with the protections extended by the *Missouri* and the *United States Constitutions*; limits the scope of such rule to the circumstances creating an emergency and requiring emergency procedure, and at the time of or prior to the adoption of such rule files with the secretary of state the text of the rule together with the specific facts, reasons, and findings which support its conclusion that there is an immediate danger to the public health, safety, or welfare which can be met only through the adoption of such rule and its reasons for concluding that the procedure employed is fair to all interested persons and parties under the circumstances.

Rules filed as emergency rules may be effective not less than ten (10) days after filing or at such later date as may be specified in the rule and may be terminated at any time by the state agency by filing an order with the secretary of state fixing the date of such termination, which order shall be published by the secretary of state in the *Missouri Register* as soon as practicable.

All emergency rules must state the period during which they are in effect, and in no case can they be in effect more than one hundred eighty (180) calendar days or thirty (30) legislative days, whichever period is longer. Emergency rules are not renewable, although an agency may at any time adopt an identical rule under the normal rulemaking procedures.

ORDER TERMINATING EMERGENCY RULE

By the authority vested in the State Board of Embalmers and Funeral Directors under sections 333.011, 333.315, 333.320, 333.325, and 333.340, as amended by Senate Bill 1, Ninety-fifth General Assembly, First Regular Session 2009, the board hereby terminates an emergency rule effective November 2, 2009.

20 CSR 2120-3.100 Notice of Intent to Apply is terminated.

EMERGENCY RULE

20 CSR 2120-3.100 Notice of Intent to Apply

PURPOSE: This emergency rule describes the board's procedure for filing a notice of intent to apply for licensure/registration under the new requirements contained in Chapters 333 and 436, RSMo, which became effective on August 28, 2009.

EMERGENCY STATEMENT: During the First Regular Session of the Ninety-fifth General Assembly, House Committee Substitute for Senate Substitute for Senate Committee Substitute for Senate Bill 1 was passed. This legislation required for the first time that preneed sellers and preneed providers be licensed and for preneed agents to be registered. This legislation enhanced enforcement powers of both the board and the Office of the Attorney General. Additionally, this legislation strengthened consumer protection and preneed contracts funded through trust, insurance, and joint accounts. This legislation took effect August 28, 2009.

The impetus for this bill was the 2008 collapse of Missouri's largest preneed funeral plan seller, National PreArranged Services (NPS), a St. Louis based preneed funeral plan seller. NPS sold preneed funeral plans in approximately forty-four (44) states and had estimated liabilities of one (1) billion dollars. NPS and its sister insurance companies are being liquidated by the District Court of Travis County, Texas. NPS was the largest third party preneed funeral plan seller in the state of Missouri and was the seller of approximately seven thousand (7,000) preneed funeral plans in Missouri at the time liquidation proceedings began. The repercussions of the liquidation of NPS will be felt throughout all of Missouri for years to come. Funeral homes will receive payment of much less than NPS promised to provide for funeral services, and some Missourians will be faced with the situation of having to pay twice for a funeral because there will be no funds available through the liquidation proceedings and there may be no funeral home in Missouri obligated to provide the funeral services. The ripple effects of this liquidation will also be felt in the economies of many Missouri communities. This matter has resulted in approximately two hundred (200) complaints to the board. Multiple lawsuits have been filed against NPS and one of NPS's central figures was recently placed under federal indictment.

Now that this legislation has passed and was effective on August 28, 2009, this emergency rule is necessary to preserve a compelling governmental interest of establishing a process through which preneed sellers, providers, and agents can continue preneed business until their newly required applications for licensure or registration can be received, reviewed, and approved or denied by the board. In the absence of such a rule, any preneed business beginning August 28, 2009, would be unlicensed activity subject under this legislation to potential administrative discipline, injunctive action, or criminal prosecution.

Adoption of this rule only through the ordinary rule making process will leave no provision for the preneed industry to conduct any business in the state of Missouri until after individual licenses can be submitted to, reviewed by, and approved or denied by the board.

As a result, the Missouri State Board of Embalmers and Funeral Directors finds that there is a compelling governmental interest that requires this emergency action. The scope of this emergency rule is limited to the circumstances creating the emergency and complies with the protections extended in the *Missouri* and *United States Constitutions*. The Missouri State Board of Embalmers and Funeral Directors believes this emergency rule is fair to all interested persons and parties under the circumstances. This emergency rule was filed October 23, 2009, becomes effective November 2, 2009, and expires March 5, 2010.

(1) Any person wishing to conduct business as a preneed seller or preneed provider or wishing to register as a preneed sales agent (the applicant) must fully complete and file with the state board a "Notice of Intent to Apply for Licensure/Registration" (notice of intent) prior to engaging in any conduct for which a preneed seller license, a preneed provider license, or a preneed sales agent registration is required. The board shall provide the notice of intent as an electronic document on its website. No fee shall be required to accompany the notice of intent. Only the official notice of intent form shall be accepted by the board.

(2) Applicants may file the notice of intent with the board by hand delivery, by mail, by fax, or by other electronic means such as email. If the notice of intent is filed by fax or other electronic means, the applicant shall also provide the original signed document to the board by mail or other delivery method.

(3) All applicants must meet the requirements for licensure as set forth in Chapter 333, RSMo, and must certify that, to the best of their knowledge, they are eligible for licensure/registration.

(4) If the board determines that the applicant lacks the statutory qualifications for licensure/registration, the board may terminate the temporary authorization to practice under the notice of intent by notifying the applicant in writing of the termination and the reason for the termination. An applicant may apply for full licensure or registration even if the board has terminated his/her authority to practice pursuant to the notice of intent.

(5) Any applicant who has filed a notice of intent must file their completed application for licensure or registration with the board no later than October 31, 2009.

(6) The applicant shall keep a copy of the notice of intent and shall prominently display this notice of intent as if it were a license or registration issued pursuant to Chapter 333, RSMo.

(7) Preneed Sellers and Providers.

(A) Any person with a filed notice of intent shall be authorized to engage in the practice of preneed selling or providing as so indicated on the notice of intent, provided that the applicant has timely filed his/her application for licensure. This authorization to practice shall be effective from the date the board receives the notice of intent and shall end on the date the board either issues a license or denies the application for licensure or until midnight on December 31, 2009, whichever comes first. The board shall promptly notify the applicant of its decision to issue a license or its denial of same.

(B) Any conduct that may be cause for discipline that occurs between August 28, 2009, and December 31, 2009, shall be considered by the board in its decision to issue or deny any application for licensure. In addition, if the board issues a license and later discovers conduct that would be cause for discipline occurred between August 28, 2009, and December 31, 2009, the board shall have authority to seek discipline against the licensee for that conduct as if the person were fully licensed while operating under the authority of the notice of intent.

(8) Preneed Agents.

(A) Any person with a filed notice of intent shall be authorized to engage in the practice as a sales agent, as so indicated on the notice of intent, provided that the applicant has timely filed his/her application for registration. This authorization to practice shall be effective from the date the board receives the notice of intent and shall end on the date the board either issues a registration or denies the application for registration or until midnight on March 31, 2010, whichever comes first. The board shall promptly notify the applicant of its decision to issue a registration or its denial of same.

(B) Any conduct that may be cause for discipline that occurs between August 28, 2009, and March 31, 2010, shall be considered

by the board in its decision to issue or deny any application for registration. In addition, if the board issues a registration and later discovers conduct that would be cause for discipline occurred between August 28, 2009, and March 31, 2010, the board shall have authority to seek discipline against the registree for that conduct as if the person were fully registered while operating under the authority of the notice of intent.

AUTHORITY: sections 333.011, 333.315, 333.320, 333.325, and 333.340, as amended by Senate Bill 1, Ninety-fifth General Assembly, First Regular Session 2009. Emergency rule filed Aug. 28, 2009, effective Sept. 7, 2009, terminated Nov. 2, 2009. Emergency rule filed Oct. 23, 2009, effective Nov. 2, 2009, expires March 5, 2010.

EMERGENCY RULE

20 CSR 2120-3.405 Preneed Agents—Missouri Law Exam

PURPOSE: This rule prescribes the process for certifying preneed seller agents to take the Missouri Law exam as a requirement for registration.

EMERGENCY STATEMENT: During the First Regular Session of the 95th General Assembly, Senate Substitute for Senate Committee Substitute for Senate Bill 1 was passed. This legislation required for the first time that preneed sellers and preneed providers be licensed and for preneed agents to be registered. This legislation enhanced enforcement powers of both the board and the Office of the Attorney General. Additionally, this legislation strengthened consumer protection and preneed contracts funded through trust, insurance, and joint accounts. This legislation took effect August 28, 2009.

The impetus for this bill was the 2008 collapse of Missouri's largest preneed funeral plan seller, National PreArranged Services (NPS), a St. Louis based preneed funeral plan seller. NPS sold preneed funeral plans in approximately forty-four (44) states and had estimated liabilities of one (1) billion dollars. NPS and its sister

insurance companies are being liquidated by the District Court of Travis County, Texas. Now that this legislation has passed and was effective on August 28, 2009, this emergency rule is necessary to preserve a compelling governmental interest of establishing a process through which preneed agents can meet the requirements for registration with the board; specifically, the completion of the Missouri Law exam.

Adoption of this rule only through the ordinary rule making process will preclude preneed agents from doing business in the state of Missouri because it would preclude them from meeting the registration requirement of completing the Missouri Law exam.

*As a result, the Missouri State Board of Embalmers and Funeral Directors finds that there is a compelling governmental interest that requires this emergency action. The scope of this emergency rule is limited to the circumstances creating the emergency and complies with the protections extended in the **Missouri and United States Constitutions**. The Missouri State Board of Embalmers and Funeral Directors believes this emergency rule is fair to all interested persons and parties under the circumstances. This emergency rule was filed October 23, 2009, becomes effective November 2, 2009, and expires April 1, 2010.*

AUTHORITY: sections 333.325.5 and 333.340, as amended by Senate Bill 1, Ninety-fifth General Assembly, First Regular Session 2009. Emergency rule filed Sept. 24, 2009, effective Oct. 4, 2009, terminated Nov. 2, 2009. Emergency rule filed Oct. 23, 2009, effective Nov. 2, 2009, expires April 1, 2010. Original rule filed Sept. 24, 2009.

(1) All preneed agents registering with the board shall achieve a grade of seventy-five percent (75%) or greater on the Missouri Law exam.

(2) Successful completion of the Missouri Law exam shall be a prerequisite to registration.

(3) This exam may be taken any time after filing the Notice of Intent to Apply.

(4) Preneed agent applicants must successfully complete the Missouri Law exam on or before March 31, 2010, prior to the expiration of the Notice of Intent to Apply.

(5) The Missouri Law exam covers the following:

(A) Knowledge of Chapter 333, RSMo;

(B) Rules governing the practice of embalming, funeral directing, and funeral home licensing along with government benefits, statutes, and rules governing the care, custody, shelter, disposition, and transportation of dead human bodies;

(C) Knowledge of sections 436.400 to 436.520, RSMo, relating to preneed statutes;

(D) Knowledge of Chapters 193 and 194, RSMo, relating to the Missouri Department of Health and Senior Services statutes; and

(E) Questions regarding Federal Trade Commission rules and regulations and Occupational Safety and Health Administration (OSHA) requirements as they apply to Missouri licensees.

(6) Notification of intent to take this examination shall be received by the board at least fifteen (15) working days prior to the date the candidate plans to sit for the examination.





Under this heading will appear the text of proposed rules and changes. The notice of proposed rulemaking is required to contain an explanation of any new rule or any change in an existing rule and the reasons therefor. This is set out in the Purpose section with each rule. Also required is a citation to the legal authority to make rules. This appears following the text of the rule, after the word "Authority."

Entirely new rules are printed without any special symbology under the heading of the proposed rule. If an existing rule is to be amended or rescinded, it will have a heading of proposed amendment or proposed rescission. Rules which are proposed to be amended will have new matter printed in boldface type and matter to be deleted placed in brackets.

An important function of the *Missouri Register* is to solicit and encourage public participation in the rulemaking process. The law provides that for every proposed rule, amendment, or rescission there must be a notice that anyone may comment on the proposed action. This comment may take different forms.

If an agency is required by statute to hold a public hearing before making any new rules, then a Notice of Public Hearing will appear following the text of the rule. Hearing dates must be at least thirty (30) days after publication of the notice in the *Missouri Register*. If no hearing is planned or required, the agency must give a Notice to Submit Comments. This allows anyone to file statements in support of or in opposition to the proposed action with the agency within a specified time, no less than thirty (30) days after publication of the notice in the *Missouri Register*.

An agency may hold a public hearing on a rule even though not required by law to hold one. If an agency allows comments to be received following the hearing date, the close of comments date will be used as the beginning day in the ninety (90)-day-count necessary for the filing of the order of rulemaking.

If an agency decides to hold a public hearing after planning not to, it must withdraw the earlier notice and file a new notice of proposed rulemaking and schedule a hearing for a date not less than thirty (30) days from the date of publication of the new notice.

Chapter 1—Organization**

PROPOSED AMENDMENT

8 CSR 50-1.010 Organization of Division of Workers' Compensation. The division is amending the purpose statement and sections (1) and (2).

PURPOSE: This amendment deletes the date reference to the RSMo and revises the addresses of Division of Workers' Compensation offices. It also sets forth the various hearings conducted by the division.

PURPOSE: This rule describes the purposes and functions of the Division of Workers' Compensation as required by section 536.023,

RSMo [(1986)].

(1) The Workers' Compensation Division of the Department of Labor and Industrial Relations administers the Workers' Compensation Law, Chapter 287, RSMo [(1986)] to insure injured employees receive prompt and adequate medical treatment, payment of benefits of wage loss, compensation for permanent disability, and physical rehabilitation for the severely injured by providing assistance to injured workers, to include filing of claims and conducting hearings to resolve disputes between employers and employees relating to Workers' Compensation benefits. **The division also conducts hearings relating to medical fee disputes, tort victims' compensation, crime victims compensation, and line of duty compensation benefits.**

Chapter 110—Sales/Use Tax—Exemptions**

PROPOSED AMENDMENT

12 CSR 10-110.900 Farm Machinery and Equipment Related Exemptions. The director proposes to amend the title, purpose, and sections (1) through (4),

PURPOSE: This amendment incorporates the amendments to section 144.030.2(22), RSMo, from TAFP HCS SCS SB 355 (2005), and the addition of section 144.063, RSMo, from TAFP CCS HCS SS SCS SB 931, enacted by the Ninety-fourth General Assembly 2008.

PURPOSE: Sections 144.030.2(22), 144.045.1, [and] 144.047, and 144.063, RSMo, exempt certain farm machinery, equipment, repair parts, [and] supplies, lubricants, and fuels from taxation. This rule explains which items qualify for these exemptions.

(1) In general, the purchase of farm machinery, equipment, and repair and replacement parts and supplies and lubricants used exclusively, solely, and directly for producing crops, raising and feeding livestock, fish or poultry, or producing milk for ultimate sale at retail, and motor fuel used for agricultural purposes is exempt from tax.

(2) Definition of Terms.

(A) **Equipment**—Devices that have a degree of permanence to the business, contribute to multiple processing cycles over time, and generally constitute fixed assets, other than land and buildings, that are capitalized and depreciated for purposes of business and accounting practices.

[(A)](B) **Farm machinery, equipment and parts**—Machinery, [and] equipment, and parts used directly and exclusively in the agricultural production process.

(C) **Machinery**—Combinations of parts that work together as a functioning unit, even if they are subordinate elements of more complex machinery. Machinery may be simple or complex, but does not include the replacement of an individual part, even if that part becomes an element of a functioning machine.

(D) **Motor fuel**—Gasoline, diesel fuel, kerosene, and blended fuel, as defined in section 142.800, RSMo.

[(B)](E) **Repair and replacement parts**—[Items] Articles of tangible personal property that are components of [exempt farm] machinery and equipment, which can be separated from the machinery or equipment and replaced. Like machinery and equipment, parts must have a degree of permanence and durability. Included in the repair and replacement part category are batteries, tires, fan belts, mufflers, spark plugs, oil filters, plow parts, standard type motors, and cutting parts. Substances such as coolants that are added to machinery and equipment for operation are not parts. Substances such as paints or adhesives that adhere to the surface of machinery and equipment, but are not distinct articles of tangible personal property, are not parts.

(F) For the purposes of this rule, supplies shall mean—Tangible personal property consumed in producing crops or milk, or raising and feeding livestock, fish, poultry, pheasants, chukar, or quail for ultimate sale at retail.

(3) Basic Application of Exemption.

(A) To qualify for exemption pursuant to section 144.030.2(22), RSMo, items purchased must be—

1. Used exclusively for agricultural purposes;
2. Used on land owned or leased for the purpose of producing farm products; and
3. Used directly in producing farm products to be sold ultimately in processed form or otherwise at retail or in producing farm products to be fed to livestock or poultry to be sold ultimately in processed form at retail. The term “used directly” encompasses items that are used in some manner prior to the actual commencement of production, during production, or in some manner after the production has terminated. In determining whether items are used directly, consideration must be given to the following factors:

- A. Where the items in question are used;
- B. When the items in question are used; and
- C. How the items in question are used to produce a farm product.]; and]

[4. Farm machinery or equipment that meet these requirements are exempt from tax, as are repair or replacement parts there on and lubricants used exclusively for such farm machinery or equipment and one half (1/2) of any diesel fuel used in such machinery or equipment.]

(B) Pursuant to section 144.045.1, RSMo, farm machinery or equipment that would otherwise qualify as exempt farm machinery and equipment will not lose its exempt status merely because the machinery or equipment is attached to a vehicle or real property. Such equipment includes, but is not limited to, a grinder mixer mounted on a vehicle or special livestock flooring. When exempt farm machinery or equipment attached to a motor vehicle is sold with the motor vehicle, the part of the total sales price attributable to the farm machinery or equipment is exempt from tax if the farm machinery or equipment is separately invoiced. **If not separately invoiced, the total sales price is subject to tax as a motor vehicle.**

(C) Pursuant to section 144.047, RSMo, farm machinery includes aircraft used solely for aerial application of agricultural chemicals.

(D) Pursuant to section 144.030.2(34), RSMo, all sales of grain bins for storage of grain for resale are exempt; [however] pursuant to this section, parts purchased separately for these bins are not exempt. However, [G]grain bins, [and] including all parts, [purchased] that are used in production of a farm product and qualify as farm machinery and equipment are exempt pursuant to section 144.030.2(22), RSMo.

(E) Pursuant to section 144.063, RSMo, fencing and motor fuel used for agricultural purposes are exempt.

[(E)](F) The fact that particular items may be considered to be essential or necessary will not automatically entitle them to exemption. The following categories of items are excluded from the meaning of the term farm machinery and farm equipment, including supplies, and are subject to tax:

1. [Under no circumstances can a] A motor vehicle and parts for a motor vehicle do not qualify as exempt farm machinery or equipment. A trailer [ever be treated] and parts for a trailer generally do not qualify as tax exempt farm machinery or equipment. The terms motor vehicle and trailer are defined by [the titling and licensing laws of Missouri [Chapter 301]], RSMo;

2. Containers and storage devices such as oil and gas storage tanks, pails, buckets, and cans;

3. Hand tools and hand-operated [equipment] items such as wheelbarrows, hoes, rakes, pitchforks, shovels, brooms, wrenches, pliers, and grease guns;

[4. Consumable items such as antifreeze, freon, ether, and starter fluid;]

[5.]4. Attachments and accessories not essential to the operation of the machinery itself (except when sold as part of the assembled unit) such as cigarette lighters, radios, canopies, air-conditioning units, cabs, deluxe seats, tool or utility boxes and lubricators;

[6.]5. Equipment used in farm management such as communications and office equipment, repair, service, security or fire protection equipment;

[7.]6. [Drainage tile, fencing material, b]Building materials, and general heating, lighting, and ventilation equipment [for non-production areas]; and

[8.]7. Machinery and equipment used for a dual purpose, one purpose being agricultural and the other being nonagricultural are not exempt.

[(F)](G) [Schedule] **Example A** is a list of items of farm machinery, [and] equipment, and supplies [which] that will usually be exempt if used exclusively for agricultural purposes on land owned or leased for the purpose of producing farm products and used directly in producing farm products or livestock to be sold ultimately at retail.

20 CSR 1105-3.011 Definitions—Immediate Family and Household

PURPOSE: This rule defines terms that are used in Missouri credit union law, Chapter 370, RSMo, in the manner that they will be used by the Credit Union Commission and the Division of Credit Unions when implementing Chapter 370, RSMo.

(1) “Immediate family” is defined as spouse, child, sibling, parent, grandparent, grandchild, aunt, uncle, niece, nephew, first cousin, or legal guardian and includes step, in-law, and legally adoptive relationships.

(2) “Household” is defined as persons living in the same residence who maintain a single economic unit. Included in this definition is any person who is a member of and participates in the maintenance of the household.

(D) An area outside of a metropolitan area, where the median family income is at or below eighty percent (80%) of the statewide non-metropolitan area median family income or the national non-metropolitan area median family income, whichever is greater;

(E) An area where the unemployment rate is at least one hundred fifty percent (150%) of the national average; or

(F) An area meeting the criteria for economic distress that may be established by the Community Development Financial Institutions Fund of the United States Department of the Treasury.

(2) A credit union requesting the ability to serve a geographic area must document that the community is a low-income or underserved community.

PROPOSED RULE

20 CSR 2200-4.022 Nurse Licensure Compact

PURPOSE: This rule sets forth the provisions of the nurse licensure compact.

(1) Definition of terms in the compact. For the purpose of the compact—

(A) “Board”—party state’s regulatory body responsible for issuing nurse licenses;

(B) “Information system”—the coordinated licensure information system;

(C) “Primary state of residence”—the state of a person’s declared fixed permanent and principal home for legal purposes; domicile;

(D) “Public”—any individual or entity other than designated staff or representatives of party state boards or the National Council of State Boards of Nursing, Inc.; and

(E) Other terms used in these rules are to be defined as in the Interstate Compact.

(2) Issuance of a license by a compact party state. For the purpose of this compact—

(A) No applicant for initial licensure will be issued a compact license granting a multi-state privilege to practice unless the applicant first obtains a passing score on the applicable National Council Licensure Examination (NCLEX) examination or its predecessor examination used for licensure;

(B) A nurse applying for a license in a home party state shall produce evidence of the nurse’s primary state of residence. Such evidence shall include a declaration signed by the licensee. Further evidence that may be requested may include but is not limited to—

1. Driver’s license with a home address;
2. Voter registration card displaying a home address;
3. Federal income tax return declaring the primary state of residence;
4. Military Form no. 2058—state of legal residence certificate;

or

5. W-2 from US Government or any bureau, division or agency thereof indicating the declared state of residence;

(C) A nurse on a visa from another country applying for licensure in a party state may declare either the country of origin or the party state as the primary state of residence. If the foreign country is declared the primary state of residence, a single state license will be issued by the party state;

(D) A license issued by a party state is valid for practice in all other party states unless clearly designated as valid only in the state which issued the license;

(E) When a party state issues a license authorizing practice only in that state and not authorizing practice in other party states (i.e. a single state license), the license shall be clearly marked with words indicating that it is valid only in the state of issuance;

(F) A nurse changing primary state of residence, from one party state to another party state, may continue to practice under the former home state license and multi-state licensure privilege during the processing of the nurse’s licensure application in the new home state for a period not to exceed thirty (30) days;

(G) The licensure application in the new home state of a nurse under pending investigation by the former home state shall be held in abeyance and the thirty-(30) day period as stated in subsection (2)(F) shall be stayed until resolution of the pending investigation;

(H) The former home state license shall no longer be valid upon the issuance of a new home state license; and

(I) If a decision is made by the new home state denying licensure, the new home state shall notify the former home state within ten (10) business days and the former home state may take action in accordance with that state’s laws and rules.

(3) Limitations on multi-state licensure privilege—Discipline.

(A) Home state boards shall include in all licensure disciplinary orders and/or agreements that limit practice and/or require monitoring the requirement that the licensee subject to said order and/or

agreement will agree to limit the licensee's practice to the home state during the pendency of the disciplinary order and/or agreement. This requirement may, in the alternative, allow the nurse to practice in other party states with prior written authorization from both the home state and such other party state boards.

(B) An individual who had a license which was surrendered, revoked, suspended, or an application denied for cause in a prior state of primary residence, may be issued a single state license in a new primary state of residence until such time as the individual would be eligible for an unrestricted license by the prior state(s) of adverse action. Once eligible for licensure in the prior state(s), a multistate license may be issued.

(4) Information System.

(A) Levels of access.

1. The public shall have access to nurse licensure information limited to—

- A. The nurse's name;
- B. Jurisdiction(s) of licensure;
- C. License expiration date(s);
- D. Licensure classification(s) and status(es);
- E. Public emergency and final disciplinary actions, as defined

by contributing state authority; and

- F. The status of multi-state licensure privileges.

(B) Non-party state boards shall have access to all information system data except current significant investigative information and other information as limited by contributing party state authority.

(C) Party state boards shall have access to all information system data contributed by the party states and other information as limited by contributing non-party state authority.

(D) The licensee may request in writing to the home state board to review the data relating to the licensee in the information system. In the event a licensee asserts that any data relating to him or her is inaccurate, the burden of proof shall be upon the licensee to provide evidence that substantiates such claim. The board shall verify and within ten (10) business days correct inaccurate data to the information system.

(E) The board shall report to the information system within ten (10) business days—

1. Disciplinary action, agreement or order requiring participation in alternative programs or which limit practice or require monitoring (except agreements and orders relating to participation in alternative programs required to remain nonpublic by contributing state authority);

2. Dismissal of complaint;

3. Changes in status of disciplinary action, or licensure encumbrance;

4. Current significant investigative information shall be deleted from the information system within ten (10) business days upon report of disciplinary action, agreement, or order requiring participation in alternative programs or agreements which limit practice or require monitoring or dismissal of a complaint; and

5. Changes to licensure information in the information system shall be completed within ten (10) business days upon notification by a board.

7 CSR 60-2.010 is amended.

A notice of proposed rulemaking containing the text of the proposed amendment was published in the *Missouri Register* on June 15, 2009 (34 MoReg 1340–1341). Those sections with changes are reprinted here. This proposed amendment becomes effective thirty (30) days after publication in the *Code of State Regulations*.

SUMMARY OF COMMENTS: The Missouri Highways and Transportation Commission (MHTC) received one (1) comment on the proposed amendment.

COMMENT #1: Consumer Safety Technology, an ignition interlock manufacturer, submitted a comment objecting to the change in the rolling retest requirements, which increased the time period for a breath test from five (5) minutes after starting the vehicle to within fifteen (15) minutes after starting the vehicle.

RESPONSE AND EXPLANATION OF CHANGE: Although this language was initially changed based on recommendations received from another ignition interlock manufacturer, MHTC concurs with

this comment and the language in this section will revert to the original language that required a breath test five (5) minutes after starting the vehicle and randomly during each subsequent thirty (30)-minute period thereafter. This comment will also impact 7 CSR 60-2.030(1)(C)2., which establishes the parameters for a violations retest message and includes the fifteen (15)-minute requirement to provide a breath test.

7 CSR 60-2.010 Definitions

(1) Definitions.

(A) The following words and terms as used in these requirements shall have the following meaning:

1. Alcohol retest setpoint—The breath alcohol concentration at which the ignition interlock device is set to lock the ignition for the rolling retest;

2. Alcohol setpoint—The breath alcohol concentration at which the ignition interlock device is set to lock the ignition. The alcohol setpoint is the nominal lock point at which the ignition interlock device is set at the time of calibration;

3. Alveolar air—Deep lung air or alveolar breath, which is the last portion of a prolonged, uninterrupted exhalation;

4. Authorized service provider—A person, company, or authorized franchise who is certified by the state of Missouri to provide breath alcohol ignition interlock devices under sections 577.600–577.614, RSMo;

5. Bogus breath sample—Any gas sample other than an unaltered, undiluted, and unfiltered alveolar air sample from a driver;

6. Breath alcohol concentration (BAC)—The number of grams of alcohol (% weight/volume) per two hundred ten (210) liters of breath;

7. Breath alcohol ignition interlock device (BAIID)—A mechanical unit that is installed in a vehicle which requires the taking of a BAC test prior to the starting of the vehicle and at periodic intervals after the engine has been started. If the unit detects a BAC test result below the alcohol setpoint, the unit will allow the vehicle's ignition switch to start the engine. If the unit detects a BAC test result at or above the alcohol setpoint, the vehicle will be prohibited from starting;

8. Breath sample—Expired human breath containing primarily alveolar air;

9. Calibration—The process which ensures an accurate alcohol concentration reading on a device;

10. Circumvention—An unauthorized, intentional, or overt act or attempt to start, drive, or operate a vehicle equipped with a breath alcohol ignition interlock device without the driver of the vehicle providing a pure breath sample;

11. Device—Breath alcohol ignition interlock device (BAIID);

12. Download—The transfer of information from the interlock device's memory onto disk or other electronic or digital transfer protocol;

13. Emergency service—Unforeseen circumstances in the use and/or operation of a breath alcohol ignition interlock device, not covered by training or otherwise documented, which requires immediate action;

14. Filtered breath sample—A breath sample which has been filtered through a substance in an attempt to remove alcohol from the sample;

15. Independent laboratory—A laboratory which is properly equipped and staffed to conduct laboratory tests on ignition interlock devices;

16. Initial breath test—A breath test required to start a vehicle to ensure that the driver's BAC is below the alcohol setpoint;

17. Installation—Mechanical placement and electrical connection of a breath alcohol ignition interlock device in a vehicle by installers;

18. Installer—A dealer, distributor, supplier, individual, or service center who provides device calibration, installation, and other related activities as required by the authorized service provider;

19. Lockout—The ability of the device to prevent a vehicle’s engine from starting unless it is serviced or recalibrated;

20. NHTSA—Federal agency known as the National Highway Traffic Safety Administration;

21. Operator—Any person who operates a vehicle that has a court-ordered or Department of Revenue required breath alcohol ignition interlock device installed;

22. Permanent lockout—A feature of a device in which a vehicle will not start until the device is reset by a device installer;

23. Pure breath sample—Expired human breath containing primarily alveolar air and having a breath alcohol concentration below the alcohol setpoint of twenty-five thousandths (.025);

24. Reinstallation—Replacing a breath alcohol ignition interlock device in a vehicle by an installer after it has been removed for service;

25. Retest—Two (2) additional chances to provide a breath sample below the alcohol setpoint when the first sample failed; or three (3) chances to provide a breath alcohol sample below the alcohol setpoint on the rolling retest;

26. Rolling retest—A subsequent breath test that must be conducted five (5) minutes after starting the vehicle and randomly during each subsequent thirty (30)-minute time period thereafter while the vehicle is in operation;

27. Service lockout—A feature of the breath alcohol ignition interlock device which will not allow a breath test and will not allow the vehicle to start until the device is serviced and recalibrated as required;

28. Tampering—An overt, purposeful attempt to physically alter or disable an ignition interlock device, or disconnect it from its power source, or remove, alter, or deface physical anti-tampering measures, so a driver can start the vehicle without taking and passing an initial breath test;

29. Temporary lockout—A feature of the device which will not allow the vehicle to start for fifteen (15) minutes after three (3) failed attempts to blow a pure breath sample; and

30. Violations reset—A feature of a device in which a service reminder is activated due to one (1) of the following reasons:

A. Two (2) fifteen (15)-minute temporary lockouts within a thirty (30)-day period; or

B. Any two (2) refusals to provide a retest sample within a thirty (30)-day period.

SUMMARY OF COMMENTS: The Missouri Highways and Transportation Commission (MHTC) received one (1) comment on the proposed amendment.

COMMENT #1: Consumer Safety Technology, an ignition interlock manufacturer, submitted a comment objecting to the change in the rolling retest requirements, which increased the time period for a breath test from five (5) minutes after starting the vehicle to within fifteen (15) minutes after starting the vehicle.

7 CSR 60-2.030 Standards and Specifications

(1) Standards and Specifications.

(C) A retest feature is required for all devices.

1. A device shall be programmed to require a rolling retest five (5) minutes after the start of the vehicle and randomly during each subsequent thirty (30)-minute time period thereafter as long as the vehicle is in operation.

2. Any breath sample above the alcohol retest setpoint of twenty-five thousandths (.025) or any failure to provide a retest sample within five (5) minutes shall activate the vehicle’s horn or other installed alarm and/or cause the vehicle’s emergency lights to flash until the engine is shut off by the operator. Three (3) breath samples above the alcohol setpoint or three (3) consecutive refusals by the driver to provide a retest sample will result in a violations reset message.

3. The violations reset message shall instruct the operator to return the device to the installer for servicing within five (5) working days.

A. As the result of a reset message, the installer must download and calibrate the device.

B. The installer must report all violations to the court-ordered supervising authority within three (3) working days.

4. If the vehicle is not returned to the installer within five (5) working days, the device shall cause the vehicle to enter a permanent lockout condition.

This list is provided as a guideline to assist public bodies with their responsibilities under this section that states, "any county, city, town, village or any other political subdivision which requires a building permit for a person to perform certain construction projects shall require a transient employer to show proof that the employer has been issued a tax clearance and has filed a financial assurance instrument as required by Section 285.230 before such entity issues a building permit to the transient employer."
