

**T**his section will contain the final text of the rules proposed by agencies. The order of rulemaking is required to contain a citation to the legal authority upon which the order or rulemaking is based; reference to the date and page or pages where the notice of proposed rulemaking was published in the *Missouri Register*; an explanation of any change between the text of the rule as contained in the notice of proposed rulemaking and the text of the rule as finally adopted, together with the reason for any such change; and the full text of any section or subsection of the rule as adopted which has been changed from that contained in the notice of proposed rulemaking. The effective date of the rule shall be not less than thirty (30) days after the date of publication of the revision to the *Code of State Regulations*.

**T**he agency is also required to make a brief summary of the general nature and extent of comments submitted in support of or opposition to the proposed rule and a concise summary of the testimony presented at the hearing, if any, held in connection with the rulemaking, together with a concise summary of the agency's findings with respect to the merits of any such testimony or comments which are opposed in whole or in part to the proposed rule. The ninety-(90-) day period during which an agency shall file its order of rulemaking for publication in the *Missouri Register* begins either: 1) after the hearing on the proposed rulemaking is held; or 2) at the end of the time for submission of comments to the agency. During this period, the agency shall file with the secretary of state the order of rulemaking, either putting the proposed rule into effect, with or without further changes, or withdrawing the proposed rule.

SUMMARY OF COMMENTS: No comments were received.

**ORDER OF RULEMAKING**

By the authority vested in the State Board of Education under sections 161.092 and 160.400–160.425, RSMo Supp. 2012, the board adopts a rule as follows:

5 CSR 20-100.260 is adopted.

A notice of proposed rulemaking containing the text of the proposed rule was published in the *Missouri Register* on January 2, 2013 (38 MoReg 99–104). Those sections with changes are reprinted here. This proposed rule becomes effective thirty (30) days after publication in the *Code of State Regulations*.

SUMMARY OF COMMENTS: The State Board of Education (board) received one hundred one (101) comments regarding the proposed rule.

COMMENT #1: The Department of Elementary and Secondary Education (department) received one (1) comment from Mike Wood, Missouri State Teachers Association, that stated that sponsors should take a more active role in ensuring success for school and supporting the proposed rule.

RESPONSE: The board reviewed the comment and determined no change is needed.

Due to the similarity in the following four (4) comments, one (1) response that addresses these comments is presented after the four (4) comments.

COMMENT #2: One (1) comment from Charles Smith, Missouri National Education Association (MNEA), that stated that sponsors of charter schools should ensure that the schools they sponsor meet student performance and fiscal standards as addressed in the proposed rule.

COMMENT #3: One (1) comment from Chris Guinther, MNEA, that stated that sponsors of charter schools should ensure that the schools they sponsor meet student performance and fiscal standards as addressed in the proposed rule.

COMMENT #4: Seven (7) comments from teachers that stated that sponsors of charter schools should ensure that the schools they sponsor meet student performance and fiscal standards as addressed in the proposed rule.

COMMENT #5: One (1) comment from Kenneth Holzapfel, taxpayer, that stated that sponsors of charter schools should be held accountable for performance and fiscal standards.

RESPONSE: The board reviewed the comments and determined no change is needed.

COMMENT #6: One (1) comment from Chris Guinther, MNEA, that stated in section (1), that sponsors should designate liaisons to

each sponsored charter school for communication purposes and ensure the provision of high-quality mentoring.

RESPONSE: The board reviewed the comment and determined no change will be made. Currently, liaisons are designated and mentoring is required for continuing certification of all new educators.

COMMENT #7: One (1) comment from Cami Fick, with the department, recommended changing the words “A quality sponsor” to “The sponsor” and in the second sentence, replacing the words “is expected to meet” to “shall implement steps to closely monitor” in section (1).

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to make this change to section (1) to provide consistency throughout the document.

COMMENT #8: One (1) comment from Cami Fick, with the department, recommended changing wording for clarity purposes in subsection (1)(A).

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to make this change to clarify subsection (1)(A).

COMMENT #9: One (1) comment from Deborah Carr, Missouri Charter School Sponsor Network (MCSSN), supporting subsection (1)(D) ensuring development of policies and procedures.

RESPONSE: The board reviewed the comment and determined no change is needed.

COMMENT #10: One (1) comment from Steve Sanchez and Martha McGeehon, St. Louis University (SLU), regarding subsection (1)(B) and suggested that the department should direct sponsors on what to do if the background check findings are adverse.

RESPONSE: The board reviewed the comment and determined no change will be made. The department has a complete process to handle adverse findings for certificated educators, and local school boards should consult their attorneys in regard to handling other employees.

Due to the similarity in the following three (3) comments, one (1) response that addresses these comments is presented after the three (3) comments.

COMMENT #11: Three (3) comments from Deborah Carr, MCSSN, regarding percentage of funds used to support charter school operations and compliance as stated in subsection (1)(E).

COMMENT #12: One (1) comment from Steve McClure, University of Missouri Kansas City (UMKC) Charter School Center, regarding percentage of funds used to support charter school operations and compliance as stated in subsection (1)(E).

COMMENT #13: One (1) comment from Deborah Carr, University of Missouri—Columbia (MU) Office of Charter School Operations, regarding percentage of funds used to support charter school operations and compliance as stated in subsection (1)(E).

RESPONSE: The board reviewed the comments and determined no change will be made. The law states that ninety percent (90%) of funds will go towards sponsorship, but does not state when funds must be spent. The rule clarifies that submission of an annual report will be required indicating how such funds were spent.

COMMENT #14: One (1) comment from Steve McClure, UMKC Charter School Center, that recommended wording in subsection (1)(F) be changed for alternative and special purpose charter schools serving high risk students whose performance will be judged on student academic and behavioral growth measures, as defined in the school’s performance contract with its sponsor.

RESPONSE: The board reviewed the comment and determined no change will be made. The department is studying alternative performance evaluations.

Due to the similarity in the following three (3) comments, one (1) response that addresses these comments is presented after the three (3) comments.

COMMENT #15: One (1) comment from Deborah Carr, MU Office of Charter School Operations, that recommended wording in subsection (1)(F) be changed from “ensure” to “retain.”

COMMENT #16: One (1) comment from Deborah Carr, MCSSN, that recommended wording in subsection (1)(F) be changed from “ensure” to “retain.”

COMMENT #17: One (1) comment from Douglas Thaman, Missouri Charter Public School Association (MCPA), that regarded changing wording in subsection (1)(F) to illustrate that sponsors of charter schools have intervention capacity.

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to revise subsection (1)(F) to address that sponsors maintain capacity for intervention.

COMMENT #18: One (1) comment from Douglas Thaman, MCPA, that regarded limiting portfolio of sponsors if they have two (2) or more low performing schools on the Annual Performance Report (APR) metric as mentioned in subsection (1)(F).

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to revise the wording to comply with the federal waiver definition of persistently low achieving schools. Best practices suggest that a sponsor with two (2) or more persistently low achieving schools focus on improving current schools rather than expanding their portfolio. Missouri’s methodology for identifying priority schools is defined in Missouri’s Elementary and Secondary Education Act’s *Flexibility Request* and will be used in the identification of schools that are: a.) Among the lowest five percent (5%) of Persistently Low Achieving (PLA) Title I schools in the state, based on the achievement of students in the total population group in terms of proficiency on assessments that are part of the State Education Agency’s (SEA) differentiated accountability system and have demonstrated minimal progress in improving the achievement of the school’s total population over a period of years; b.) Title I participating or eligible high schools with a graduation rate less than sixty percent (60%) over a period of years.

Due to the similarity in the following four (4) comments, one (1) response that addresses these comments is presented after the four (4) comments.

COMMENT #19: One (1) comment from Steve Sanchez and Martha McGeehon, SLU, that recommended wording in subsection (1)(F) on the definition of low performing.

COMMENT #20: One (1) comment from Deborah Carr, MU Office of Charter School Operations, that recommended wording in subsection (1)(F) regarding the definition of low performing.

COMMENT #21: One (1) comment from Deborah Carr, MCSSN, that recommended wording in subsection (1)(F) regarding the definition of low performing.

COMMENT #22: One (1) comment from Douglas Thaman, MPCSA, that regarded the definition of low performing schools and who will judge if the intervention capacity is sufficient as mentioned in subsection (1)(F).

RESPONSE: The board reviewed the comments and determined no change will be made. Persistently low performing schools are determined by the school’s Missouri Assessment Program results and/or its graduation. Section 160.405.8(1)(a), RSMo, specifically addresses intervention policies and the three (3) criteria connected with intervention policies. If intervention policies are not producing academic improvements, then capacity would be deemed insufficient.

COMMENT #23: One (1) comment from Cami Fick, with the department, recommended removing the word “quality” in “A quality sponsor” and replacing with “The sponsor.” Also, removing language “implements a thorough” and replacing with “small implementation steps to closely monitor the.”

RESPONSE AND EXPLANATION OF CHANGE: The board agreed

to make this change to section (2) to provide consistency throughout the document.

COMMENT #24: One (1) comment from Cami Fick, with the department, that recommended changing the words “implements” to “produces” in subsection (2)(A).

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to make this change to subsection (2)(A).

COMMENT #25: One (1) comment was received from Carter Ward, Missouri School Boards’ Association (MSBA), that recommended that the department clarify the sponsor’s responsibility to provide evidence of financial stability by changing the wording of subsection (2)(B).

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to revise subsection (2)(B) by changing “policy” to “criteria” and removing language “while providing a timeline for submitted and approval/denial;” and replacing with “does so in accordance to a clearly established timeline.”

COMMENT #26: One (1) comment was received from Carter Ward, MSBA, that recommended that the department clarify the sponsor’s responsibility to provide evidence of financial stability in subsection (2)(C).

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to make this change to subsection (2)(C) by requiring evidence of accountability.

COMMENT #27: One (1) comment from Victoria Hughes, University of Central Missouri (UCM), that recommended the inclusion of language defining the sponsors’ obligations to give priority to high-risk schools.

RESPONSE: The board reviewed the comment and declined to make changes. Current law clearly states that priority is given to address high-risk students in section 160.405.2(5), RSMo.

Due to the similarity in the following three (3) comments, one (1) response that addresses these comments is presented after the three (3) comments.

COMMENT #28: One (1) comment from Deborah Carr, MU Office of Charter School Operations, that recommended wording in subsection (2)(E) regarding third-party providers.

COMMENT #29: One (1) comment from Deborah Carr, MCSSN, that recommended wording in subsection (2)(E) regarding third-party providers.

COMMENT #30: One (1) comment from Douglas Thaman, MPCSA, that regarded sponsor oversight and changing wording of subsection (2)(E) so sponsors consider the outcomes of any third-party service provider when reviewing the school’s academic performance and operational management.

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to change the wording in subsection (2)(E). Due to history of third-party services, best practices indicate that sponsors verify that rigorous and independent contract oversight by governing boards be established.

Due to the similarity in the following three (3) comments, one (1) response that addresses these comments is presented after the three (3) comments.

COMMENT #31: One (1) comment from Deborah Carr, MU Office of Charter School Operations, that recommended wording in subsection (2)(F) regarding application submittal timelines.

COMMENT #32: One (1) comment from Deborah Carr, MCSSN, that recommended wording in subsection (2)(F) regarding application submittal timelines.

COMMENT #33: One (1) comment from Doug Thaman, MPCSA, that regarded deadlines for new and renewal applications and recommending subsection (2)(F) be removed.

RESPONSE: The board reviewed the comments and determined no

change will be made. Best practices indicate if a charter school is not going to be renewed that the process begins earlier rather than later. Sections 160.405.2(1) and (4), RSMo, state that the board must approve new charter applications by December 1 and that the board has sixty (60) days to review applications prior to approval. Sixty (60) days prior to December 1 would be an October 1 deadline for submission.

COMMENT #34: One (1) comment from Carter Ward, MSBA, that regarded the first sentence in section (3) is intended as a call for action.

RESPONSE AND EXPLANATION OF CHANGE: The board reviewed the comment and changed the sentence in section (3) to clarify sponsor's implementation of board support.

COMMENT #35: One (1) comment from Carter Ward, MSBA, regarding subsection (3)(A) typographical error.

RESPONSE AND EXPLANATION OF CHANGE: The board reviewed the comment and removed the "s" from "Ensures" in subsection (3)(A).

Due to the similarity in the following three (3) comments, one (1) response that addresses these comments is presented after the three (3) comments.

COMMENT #36: One (1) comment from Deborah Carr, MU Office of Charter School Operations, that recommended wording in subsection (3)(A) regarding board member training.

COMMENT #37: One (1) comment from Deborah Carr, MCSSN, that recommended wording in subsection (3)(A) regarding governing board training.

COMMENT #38: One (1) comment from Doug Thaman, MPCSA, that regarded training for governing board members in subsection (3)(A).

RESPONSE: The board reviewed the comments and declined to make changes. Best practices indicate charter boards, as well as traditional public school boards, require training to fulfill their positions.

COMMENT #39: One (1) comment from Carter Ward, MSBA, that regarded paragraph (3)(B)3. for the removal of specific words based on the statutory language covering more than just conflicts with contracts.

RESPONSE AND EXPLANATION OF CHANGE: The board agreed and made the changes by removing "with retaining contracts," in paragraph (3)(B)3.

COMMENT #40: One (1) comment from Carter Ward, MSBA, that regarded subsection (3)(C) and stated that the list is not an exhaustive list of items.

RESPONSE AND EXPLANATION OF CHANGE: The department reviewed the comment and changed subsection (3)(C) to provide the necessary examples.

Due to the similarity in the following six (6) comments, one (1) response that addresses these comments is presented after the six (6) comments.

COMMENT #41: One (1) comment from Steve McClure, UMKC Charter School Center, that provided a corrected citation of additional sections outlined in Missouri Sunshine Laws as mentioned in subsection (3)(D).

COMMENT #42: One (1) comment from Doug Thaman, MPCSA, that recommended clarification of the role of the sponsor in subsection (3)(D).

COMMENT #43: One (1) comment from Deborah Carr, MU Office of Charter School Operations, that recommended wording in subsection (3)(D) requesting change of "Ensure" to "Monitor."

COMMENT #44: One (1) comment from Steve Sanchez and Martha McGeehon, SLU, that recommended wording in subsection (3)(D) to

replace "Ensure."

COMMENT #45: One (1) comment from Deborah Carr, MCSSN, that recommended wording in subsection (3)(D) requesting change of "Ensure" to "Monitor."

COMMENT #46: One (1) comment from Carter Ward, MSBA, that regarded subsection (3)(D) and recommended sentence clarification with rewording.

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to correct the citation, clarify terminology, and correct grammatical errors in subsection (3)(D).

COMMENT #47: One (1) comment from Carter Ward, MSBA, that regarded section (4) and sought clarification for the sponsor's actions in academic performance.

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to revise wording in section (4) for clarity and consistency.

COMMENT #48: One (1) comment from Victoria Hughes, UCM, that requested the addition to section (4) of a different time frame for performance within a high-risk school.

RESPONSE: The board declined to make this change. Current law, section 160.405.4(6)(c), RSMo, provides a different time frame in meeting performance standards. However, performance standards must be met prior to graduation. The department is studying alternative performance evaluations.

COMMENT #49: One (1) comment from Brent Fullington, teacher, in subsection (4)(A) that requested that all charter schools be held responsible for the same Missouri School Improvement Program (MSIP) standards as district-run schools.

RESPONSE: The board declined to make this change. Section 160.405.4(6)(a), RSMo, establishes that charter schools are held accountable for academic standards adopted by the board. In addition, no charter school will be considered in the MSIP review for resource or process standards.

Due to the similarity in the following three (3) comments, one (1) response that addresses these comments is presented after the three (3) comments.

COMMENT #50: One (1) comment from Deborah Carr, MU Office of Charter School Operations, that recommended wording in subsection (4)(A) to eliminate the word "including" and the following list.

COMMENT #51: One (1) comment from Deborah Carr, MCSSN, that recommended wording in subsection (4)(A) to eliminate the word "including" and the following list.

COMMENT #52: One (1) comment from Doug Thaman, MPCSA, that recommended updating wording in subsection (4)(A) to ensure that performance contracts are aligned to section 160.405.4(6)(a), RSMo.

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to revise subsection (4)(A) in order to clarify standards alignment with statutory requirements.

Due to the similarity in the following two (2) comments, one (1) response that addresses these comments is presented after the two (2) comments.

COMMENT #53: One (1) comment from Deborah Carr, MU Office of Charter School Operations, that recommended changing the wording in subsection (4)(C) from "Ensure clear consequences" to "Establishes clear procedures and consequences...."

COMMENT #54: One (1) comment from Deborah Carr, MCSSN, that recommended changing the wording in subsection (4)(C) from "Ensure clear consequences" to "Establishes clear procedures and consequences...."

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to revise subsection (4)(C) in order to clarify the sentence.

COMMENT #55: One (1) comment from Cami Fick, with the department, that corrected the verb at the beginning of the sentence of subsection (4)(D).

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to revise subsection (4)(D) for clarification.

Due to the similarity in the following four (4) comments, one (1) response that addresses these comments is presented after the four (4) comments.

COMMENT #56: One (1) comment from Deborah Carr, MU Office of Charter School Operations, that recommended rewording in subsection (4)(D) objecting to limitation on probationary charters.

COMMENT #57: One (1) comment from Steve Sanchez and Martha McGeehon, SLU, that recommended rewording in subsection (4)(D) to limiting expansion of grade levels.

COMMENT #58: One (1) comment from Deborah Carr, MCSSN, that recommended rewording in subsection (4)(D) objecting to limitations on probationary charters.

COMMENT #59: One (1) comment from Doug Thaman, MPCSA, that recommended removing subsection (4)(D) regarding expansion of charter schools.

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to eliminate in subsection (4)(D) the probationary clause while retaining the limits on expansion when a charter local education agency is designated as low achieving as described in the department's federal waiver. Best practices indicate if a charter school is identified as persistently low achieving, before expanding that school with additional grades, that the intervention activities produce results to mitigate the low performance status.

COMMENT #60: One (1) comment from Carter Ward, MSBA, that regarded section (5) and recommended correct wording in the second sentence to clarify action requested.

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to make this change to section (5) allowing sponsors to implement steps for financial and performance issues.

COMMENT #61: One (1) comment from Chris Guinther, MNEA, that regarded section (5) and stated that the sponsors should annually report student attrition rates to the public and department to help ensure accountability.

RESPONSE: The board declined to make this change. The department is studying student transfers in existing charter schools.

COMMENT #62: One (1) comment from Judith Meyer, Board, Eagle College Prep Endeavor, that recommended in section (5) the limitation of the department and sponsors role in the financial governance of charter schools.

RESPONSE: The board declined to make changes. The department ensures that all public schools utilize best practices in the management of public funds, including the school board's internal controls to eliminate malfeasance.

COMMENT #63: One (1) comment from Cami Fick, with the department, that recommended changing the words "A quality sponsor" to "The sponsor" and replacing the words "is expected to meet" with "shall implement steps to closely monitor" in section (5).

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to make this change to section (5) to provide consistency throughout the document.

COMMENT #64: One (1) comment from Chris Guinther, MNEA, that regarded subsection (5)(A) and recommended clarifying language.

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to make this change to subsection (5)(A) complying with statutory requirements.

COMMENT #65: One (1) comment from Steve Sanchez and Martha McGeehon, SLU, that recommended wording in subsection (5)(D) concerning financial controls.

RESPONSE: The board declined to make changes. The department ensures that all public schools utilize best practices in the management of public funds, including the school board's internal controls to eliminate malfeasance.

Due to the similarity in the following five (5) comments, one (1) response that addresses these comments is presented after the five (5) comments.

COMMENT #66: One (1) comment from Deborah Carr, MU Office of Charter School Operations, that recommended wording in paragraphs (5)(D)1., 2., and 3., recommending that financial controls for revenue for operation of charter schools are expended for expenses related to the operation of the school.

COMMENT #67: One (1) comment from Deborah Carr, MCSSN, that recommended wording in paragraphs (5)(D)1., 2., and 3., recommending that financial controls for revenue for operation of charter schools are expended for expenses related to the operation of the school.

COMMENT #68: One (1) comment from Howard Denson, Jamaa Learning Center, that recommended the elimination of paragraphs (5)(D)1., 2., and 3.

COMMENT #69: One (1) comment from Patrice Coffin, Carondelet Leadership Academy, that recommended the elimination of paragraphs (5)(D)1., 2., and 3.

COMMENT #70: One (1) comment from Aaron North, Ewing Marion Kauffman Foundation, that recommended the elimination of paragraphs (5)(D)1., 2., and 3.

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to make the changes. Best practices require school boards to be actively involved in financial matters of the school and modifications to the requirements in paragraphs (5)(D)1., 2., and 3., were made.

COMMENT #71: One (1) comment from Doug Thaman, MPCSA, that recommended changes and clarification to paragraphs (5)(D)1., 2., and 3.

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to make this change to paragraphs (5)(D)1., 2., and 3., to combine three (3) items into two (2) by eliminating paragraph (5)(D)2. and then (5)(D)3. was renumbered as 2. The changed paragraph (5)(D)1. limits issuing payments to a set amount prior to board approval and paragraph (5)(D)2. allows the use of a check register, approved monthly by the local board, prior to payment of bills.

COMMENT #72: One (1) comment from Carter Ward, MSBA, that regarded paragraph (5)(D)3. and recommended eliminating ambiguity of whether or not the provision is optional.

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to make this change to paragraph (5)(D)3. modifying the word "should" to "shall."

Due to the similarity in the following three (3) comments, one (1) response that addresses these comments is presented after the three (3) comments.

COMMENT #73: One (1) comment from Doug Thaman, MPCSA, that recommended changing "ensure" throughout subsections (5)(E) through (5)(I)

COMMENT #74: One (1) comment from Deborah Carr, MU Office of Charter School Operations, recommending wording in subsections (5)(E) through (5)(I) changing "ensure" throughout subsections (5)(E) through (5)(I).

COMMENT #75: One (1) comment from Deborah Carr, MCSSN, recommending wording in subsections (5)(E) through (5)(I) changing "ensure" throughout subsections (5)(E) through (5)(I).

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to make these changes to subsections (5)(E) through (5)(I) to

change “ensure” to “Closely monitors” or “Closely monitors that.”

COMMENT #76: One (1) comment from Carter Ward, MSBA, that recommended wording in section (6) to clarify sponsors responsibility in reports/data submission.

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to make this change to section (6) by the addition of “shall implement steps.”

Due to the similarity in the following three (3) comments, one (1) response that addresses these comments is presented after the three (3) comments.

COMMENT #77: One (1) comment from Doug Thaman, MPCSA, that recommended changing the word “ensure” to “closely monitor” in section (6).

COMMENT #78: One (1) comment from Deborah Carr, MU Office of Charter School Operations, that recommended wording in section (6) changing the word “ensure.”

COMMENT #79: One (1) comment from Deborah Carr, MCSSN, that recommended wording in section (6) changing the word “ensure” to “monitor.”

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to change the wording in section (6) for clarification.

COMMENT #80: One (1) comment from Chris Guinther, MNEA, that regarded section (6) and recommended that sponsors report staff attrition rates for each sponsored school.

RESPONSE: The board declined to make changes. The department currently monitors teacher mobility and will consider studying charter schools specifically.

COMMENT #81: One (1) comment from Chris Guinther, MNEA, that regarded section (6) and recommended that sponsors report student attrition rates for each sponsored school.

RESPONSE: The board declined to make changes. The department currently monitors student mobility and will consider studying charter schools specifically.

Due to the similarity in the following two (2) comments, one (1) response that addresses these comments is presented after the two (2) comments.

COMMENT #82: One (1) comment from Deborah Carr, MU Office of Charter School Operations, that recommended wording in section (6) changing the word “ensure” to “monitors that.”

COMMENT #83: One (1) comment from Deborah Carr, MCSSN, that recommended wording in section (6) changing the word “ensure” to “monitors that.”

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to change “ensure” to better clarify the sponsor duties in section (6).

COMMENT #84: One (1) comment from Carter Ward, MSBA, recommending grammatical corrections in subsection (6)(G).

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to change “approve” to “approved” in subsection (6)(G) and make grammatical corrections to the sentence.

COMMENT #85: One (1) comment from Stephen McClure, UMKC Charter School Center, that recommended in subsection (6)(G) that when changes occur in charter goals/strategies, that only that portion of the charter be submitted to the department.

RESPONSE: The board declined to make changes. It would be an undue burden for the department to track multiple changes in multiple charters throughout the course of all charter schools’ operations.

Due to the similarity in the following four (4) comments, one (1) response that addresses these comments is presented after the four (4) comments.

COMMENT #86: One (1) comment from Carter Ward, MSBA, that recommended changing wording in section (7) to clarify the sponsor

role in oversight and evaluation of charter schools.

COMMENT #87: One (1) comment from Deborah Carr, MU Office of Charter School Operations, that recommended wording in section (7) changing the word “ensure” to “monitors that.”

COMMENT #88: One (1) comment from Deborah Carr, MCSSN, that recommended wording in section (7) changing the word “ensure” to “monitors that.”

COMMENT #89: One (1) comment from Doug Thaman, MPCSA, that recommended changing the word “ensure” to “monitor” in section (7).

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to make this change to section (7) by removing the word “quality” in the first sentence. Also in the second sentence, “implement steps to closely” was added to modify “monitor.”

COMMENT #90: One (1) comment from Carter Ward, MSBA, that recommended changing wording in subsection (7)(A) to include non-discrimination in all matters.

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to make this change in subsection (7)(A). Non-discrimination of student admissions is of utmost importance in charter schools but the department agrees that the indicator should be more inclusive regarding all forms of discrimination.

COMMENT #91: One (1) comment from Steve Sanchez and Martha McGeehon, SLU, that regarded subsection (7)(C) and suggested that the department should direct sponsors on policy/intervention plans.

RESPONSE: The board reviewed the comment and determined no change will be made. The department has a complete process to handle adverse findings for certificated educators and local school boards can consult their attorneys in regard to personnel policies of other employees.

COMMENT #92: One (1) comment from Steve Sanchez and Martha McGeehon, SLU, that asked in subsection (7)(D) whether the sponsor is responsible for finding non-compliance or whether the sponsor makes certain that non-compliance with federal statutes and guidelines is corrected.

RESPONSE AND EXPLANATION OF CHANGE: The board reviewed the comment and changed subsection (7)(D) to include both state and federal program conformity to rule and regulations both in determining non-compliance and in rectifying any non-compliance.

COMMENT #93: One (1) comment from Victoria Hughes, UCM, that requested the addition to section (8), a different time frame for decision-making within a high-risk school.

RESPONSE: The board declined to make this change. Current law, section 160.405.4(6)(c), RSMo, provides a different time frame in meeting performance standards. However, performance standards must be met prior to graduation.

COMMENT #94: One (1) comment from Cami Fick, with the department, recommended removing the word “quality” in “A quality sponsor” to “The sponsor.” Also, removing the words “designs and implements a” and replacing with “shall implement steps to closely monitor.” and grammatically changing the word “process” to “processes” in section (8).

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to make this change to section (8) by rewording the first sentence.

COMMENT #95: One (1) comment from Cami Fick, with the department, that recommended changing the word “Base” to “Bases” in paragraph (8)(A)2.

RESPONSE AND EXPLANATION OF CHANGE: The board agreed to make this change to paragraph (8)(A)2. by correcting the grammatical error.

## 5 CSR 20-100.260 Standards for Charter Sponsorship

(1) Standard 1—Sponsor Commitment and Capacity. The sponsor

recognizes that chartering is a means to foster excellent schools that meet identified needs, creates organizational structures to facilitate meeting these needs, and commits human and financial resources necessary to conduct its sponsoring duties effectively and efficiently. The sponsor shall implement steps to closely monitor the following:

(A) Provides capacity to serve as a sponsor by employing, contracting for services, or seeking expertise in other ways to ensure capacity to carry out all sponsoring activities essential to charter school oversight (including, but not limited to education leadership, curriculum, instruction, assessment, special education, federal programs, performance accountability, law, finance, and nonprofit governance);

(F) Maintains capacity for intervention purposes when charter sponsors have two (2) or more persistently low achieving charter schools, as verified by their Annual Performance Report (APR), before expanding their charter portfolio.

(2) Standard 2—Application Process and Decision Making. The sponsor shall implement steps to closely monitor the application process that includes clear application and guidance; follows fair, transparent procedures and rigorous criteria; and grants only those charter applications that demonstrate a strong capacity to establish and operate a quality charter school. The sponsor shall implement the following:

(A) Produces a thorough charter application process as outlined in section 160.400.11(2), RSMo, including the items as stated in section 160.405.1(1)–(17), RSMo;

(B) Maintains consistent criteria for accepting, approving, and denying charter applications and does so in accordance with a clearly established timeline;

(C) Requires the charter applicant to provide evidence of accountability regarding stable fiscal and organizational performance included in the charter application process, including:

1. Budget assumptions with balanced budgets; and
2. Positive cash flow reserve funds;

(E) Includes additional contractual provisions that verify rigorous, independent contract oversight by the charter governing board and the school's financial independence from the external provider (for any school contracting with a third-party provider for education design and operation or management);

(3) Standard 3—Board Support. The sponsor shall implement steps to offer ongoing support, including but not limited to: training, organization, ethical conduct, knowledge, commitment, compliance, leadership oversight, contract management, accountability, transparency, and the interpretation of the Missouri public charter school statutes/rules for charter school board(s). The sponsor shall—

(A) Ensure charter board members have adequate training to fulfill their position;

(B) Place charter schools on probation and/or revoke or non-renew a school's charter for poor governance if the charter school board does not follow statutory requirements, correct violations of statutory requirements, or continues to repeat the same violations, including, but not limited to the following:

1. The charter board retains status as a Missouri non-profit corporation as outlined in section 160.400.7, RSMo;
2. Charter board members submit ethics commission paperwork annually as outlined in sections 105.483 and 105.492, RSMo;
3. Charter boards have policies in place to prevent conflict of interests with the charter school as outlined in section 160.400.15, RSMo; and
4. All charter board members have criminal background and FCSR checks as outlined in section 160.400.14, RSMo;

(C) Demonstrate oversight of charter boards in a variety of ways, including but not limited to reviewing board minutes, attending board meetings, and verifying reporting processes; and

(D) Monitor whether charter school board and committee business is conducted as outlined in the Missouri Sunshine Laws, sections 610.010–610.030, RSMo.

(4) Standard 4—Academic Performance. The sponsor shall take steps to closely monitor state performance standards, as defined by the department, are included in the sponsor/charter contract. The sponsor—

(A) Ensures that performance contracts are aligned to the pupil academic standards adopted by the State Board of Education as outlined in section 160.405.4(6)(a), RSMo;

(C) Establishes clear procedures and consequences for failure to meet requirements and outcomes set in the sponsor/charter contract; and

(D) Does not approve additional sites or expansion of grade levels for a charter school identified as persistently low achieving, as verified by its APR.

(5) Standard 5—Fiscal Management. The sponsor shall implement steps to closely monitor the charter school performance management and financial actions that support a solvent fiscal status, including:

(A) A charter school identified as financially stressed develops a budget and education plan as outlined in section 160.417.3, RSMo. The department may withhold any payment of financial aid due to the charter school until such time as the charter school and sponsor have fully complied as outlined in section 160.417.5, RSMo;

(D) Ensures that adequate financial controls are in place to assure that revenue received for operation of the charter school are expended for expenses related to the operation of the charter school—

1. A requirement that a monthly check register is reviewed and approved by the local board prior to issuing payment for amounts in excess of one thousand dollars (\$1,000); and

2. The bank account where state funds are deposited must be established and under the control of the charter board. If a management company is contracted, personnel associated with the company shall not have direct access;

(E) Closely monitors that charter schools show fiscal management of federal grant programs in accordance with terms outlined in *Fiscal Guidance for Federal Grant Programs*;

(F) Closely monitors that charter schools have a procurement process in place as required by the *Code of Federal Regulations* 34 CFR 80.36;

(G) Closely monitors that the Annual Secretary of the Board Report (ASBR) and the annual audit are submitted to the department in the time frame outlined by Missouri statutes and that these documents are not compiled by the same auditing service. The department may withhold any payment of financial aid due to the charter school until such time as the charter school and sponsor have fully complied as outlined in section 160.415.5, RSMo;

(H) Closely monitors that the annual audit summary is published as outlined in section 165.121.5, RSMo; and

(I) Closely monitors that charter schools utilize the coding procedures prescribed in the *Missouri Financial Accounting Manual* as outlined in section 160.405.1(10), RSMo.

(6) Standard 6—Reporting. The sponsor shall implement steps to closely monitor all reports/data required by Missouri and federal law are completed and submitted in a timely manner for the department and/or legislature. The sponsor shall closely monitor the following:

(G) That approved changes to a charter throughout the term of the charter will be submitted within thirty (30) days of approval and an electronic copy will be submitted to the department reflecting approved changes.

(7) Standard 7—Oversight and Evaluation. The sponsor conducts oversight and evaluates performance for both federal and state compliance. The sponsor shall implement steps to closely monitor the following:

(A) Non-discrimination as required by federal and state laws;

(D) The compliance with all state and federal statutes and guidelines, including but not limited to: special education; all title programs; vocational/career education; food service; and services for foster, homeless, migrant, and English language learner students;

(8) Standard 8—Intervention, Renewal, Revocation, and Closure Decision Making. The sponsor shall implement steps to closely monitor transparent and rigorous processes that use comprehensive academic, financial, and operational management data to make decisions about intervention, renewal, revocation, and closure. The sponsor shall implement the following:

(A) Develops and maintains policies that have been adopted for the following areas:

1. Establishes and makes known to schools at the outset an intervention policy stating the general conditions that may trigger intervention and the types of actions and consequences that may ensue;

2. Bases the renewal process and renewal decisions on thorough analyses of a comprehensive body of objective evidence defined by the performance framework in the charter contract. Sponsors grant renewal only to schools that have achieved the standards and targets stated in the charter contract, are organizationally and fiscally viable, and have been diligent to the terms of the contract and applicable law;

3. Revokes a charter during the charter term if there is clear evidence of extreme underperformance or violation of law or the public trust that imperils students or public funds; and

4. In the event of a school closure, oversees and works with the school governing board and leadership in carrying out a detailed closure protocol that ensures timely notification to parents; orderly transition of students and student records to new schools; and disposition of school funds, property, and assets in accordance with law as outlined in section 160.400.17(1), RSMo.

SUMMARY OF COMMENTS: The commission received one (1) comment on the proposed amendment.

By the authority vested in the Missouri Real Estate Appraisers Commission under sections 43.543, 339.509, 339.511, and 339.513, RSMo Supp. 2012, and section 339.544, RSMo 2000, the commission adopts a rule as follows:

20 CSR 2245-10.010 is adopted.

A notice of proposed rulemaking containing the text of the proposed rule was published in the *Missouri Register* on December 17, 2012 (37 MoReg 2315–2316). Those sections with changes are reprinted here. The proposed rule becomes effective thirty (30) days after publication in the *Code of State Regulations*.

SUMMARY OF COMMENTS: The commission received three (3) comments on the proposed rule.

COMMENT #1: Alexis Hoskins, with StreetLinks, LLC, and Don Kelly, with the Real Estate Valuation Advocacy Association (REVAA), requested that the board clarify whether an appraisal management company (AMC) is to provide both its legal name and d.b.a. on one (1) application or if the AMC must submit two (2) full applications with all applicable fees, bonds, background checks, and state mandated reviews for its legal name and d.b.a. separately.

RESPONSE AND EXPLANATION OF CHANGE: The commission agreed that the rule should be clarified to require that each AMC only be required to submit one (1) application, but that one (1) application should include a listing of all d.b.a.s under which the AMC does business.

COMMENT #2: Robert M. Danehy, with CoreLogic Collateral Solutions, LLC, requested that the language be modified to indicate that the AMC has a system in place to review the work of licensed Missouri appraisers instead of all independent appraisers and that the services are conducted in compliance with the Uniform Standards of Professional Appraisal Practice.

RESPONSE AND EXPLANATION OF CHANGE: The commission agreed and removed the language specifying “independent” appraisers.

COMMENT #3: Don Kelly, with REVAA, requested that the commission clarify that an appraiser who has had a credential refused, denied, cancelled, revoked, or surrendered and subsequently has the credential granted or reinstated, is then eligible to serve as owner of an AMC.

RESPONSE AND EXPLANATION OF CHANGE: The commission agreed and has amended language to clarify that any person who owns more than ten percent (10%) of an AMC cannot have a license that is currently on discipline.

**20 CSR 2245-10.010** Appraisal Management Company Application Requirements

(2) An AMC which operates in this state under more than one (1) business name (d.b.a.s or “doing business as”) shall disclose the name of each d.b.a. on the application for licensure.

(3) The initial application submitted by the appraisal management company shall include the following certifications:

(B) That the AMC has in place a system to review the work of all appraisers performing appraisal services and that the services are conducted in compliance with the Uniform Standards of Professional Appraisal Practice;

(D) That the AMC has reviewed each person or entity that owns more than ten percent (10%) of the AMC and no person or entity owning more than ten percent (10%) of the AMC has a license or certificate that is currently on discipline.

**ORDER OF RULEMAKING**

By the authority vested in the Missouri Real Estate Appraisers Commission under sections 339.509 and 339.511, RSMo Supp. 2012, and section 339.544, RSMo 2000, the commission adopts a rule as follows:

20 CSR 2245-10.020 is adopted.

A notice of proposed rulemaking containing the text of the proposed rule was published in the *Missouri Register* on December 17, 2012 (37 MoReg 2316–2317). Those sections with changes are reprinted here. The proposed rule becomes effective thirty (30) days after publication in the *Code of State Regulations*.

SUMMARY OF COMMENTS: The commission received seven (7) comments on the proposed rule and also discovered one (1) incorrect reference and noted one (1) need for clarification.

COMMENT #1: Upon review of the published rules in the *Missouri Register*, the commission discovered that a reference in paragraph (1)(P)2. should be 330.500 to 339.549 to include all of the applicable statutes.

RESPONSE AND EXPLANATION OF CHANGE: The commission has corrected the paragraph to include the additional statutes.

COMMENT #2: The commission wished to clarify that an appraiser who has had a credential refused, denied, cancelled, revoked, or surrendered and subsequently has the credential granted or reinstated should then be eligible for hire by an appraisal management company (AMC).

RESPONSE AND EXPLANATION OF CHANGE: The commission has amended language in this rule to clarify that an AMC shall not employ any appraiser that is currently on discipline rather than who has ever been on discipline.

COMMENT #3: Don Kelly, with Real Estate Valuation Advocacy Association (REVAA), requested that the time frame for notifying the commission of a change to the AMC's registered agent be increased from five (5) business days to ten (10) business days.

RESPONSE: The commission decided not to take action on the comment.

COMMENT #4: Don Kelly, with REVAA, requested that the rule identify a period of time within which an AMC must respond to a request for appraisal services and payment information.

RESPONSE: The commission decided not to take action on the comment.

COMMENT #5: Don Kelly, with REVAA, requested that the commission clarify that the requirement that AMCs cannot prohibit an appraiser who is part of an appraiser panel from recording the fee that the appraiser was paid by the appraisal management company for the performance of the appraisal within the appraisal report does not apply to employee appraisers.

RESPONSE: The commission decided not to take action on the comment.

COMMENT #6: Robert M. Danehy, with CoreLogic Collateral Solutions, LLC, requested that the commission revise subsection (1)(M) to allow the acceptable modifications as stated in section (3).

RESPONSE: The commission decided not to take action on the comment.

COMMENT #7: Robert M. Danehy, with CoreLogic Collateral Solutions, LLC, requested that subsection (1)(N) be changed to reflect that if the delivery date indicated it would not allow for the development of a credible and reliable appraisal report that the appraiser must communicate to the AMC the reason for declining the order.

RESPONSE: The commission decided not to take action on the comment.

COMMENT #8: Robert M. Danehy, with CoreLogic Collateral Solutions, LLC, requested additional clarification of subsection (2)(F) be provided as it appears that the commission is attempting to regulate scope of work.

RESPONSE: The commission decided not to take action on the comment.

COMMENT #9: Robert M. Danehy, with CoreLogic Collateral Solutions, LLC, requested that language be added specifying an exact time for which an appraiser has to respond to their removal from the panel.

RESPONSE: The commission decided not to take action on the comment.

#### **20 CSR 2245-10.020 Appraisal Management Company Standards of Practice**

(1) An appraisal management company (AMC) that has been issued a registration by the Missouri Real Estate Appraisers Commission under these rules shall be responsible for complying with the following:

(I) Shall not employ any person directly involved in appraisal management services who has a license or certificate to act as an appraiser in Missouri or in any other state that is currently on discipline;

(P) Shall not require the appraiser to do anything that does not comply with the—

1. Uniform Standards of Professional Appraisal Practice;
2. Sections 339.500 to 339.549, RSMo, and the regulations promulgated thereunder; or

3. Any assignment conditions required by the client;

#### **ORDER OF RULEMAKING**

By the authority vested in the Missouri Real Estate Appraisers Commission under sections 339.511 and 339.525, RSMo Supp. 2012, and section 339.544, RSMo 2000, the commission adopts a rule as follows:

20 CSR 2245-10.030 is adopted.

A notice of proposed rulemaking containing the text of the proposed rule was published in the *Missouri Register* on December 17, 2012 (37 MoReg 2317-2318). Those sections with changes are reprinted here. This proposed rule becomes effective thirty (30) days after publication in the *Code of State Regulations*.

SUMMARY OF COMMENTS: The commission received two (2) comments and noted one (1) need for clarification on the proposed amendment.

COMMENT #1: Joseph F. Rose, with the Missouri Appraisers Advisory Council, noted that section (1) references the fee rule inconsistently. In one (1) instance the section is referenced and in another instance the entire rule is referenced.

RESPONSE AND EXPLANATION OF CHANGE: The commission agrees that it is good to be consistent. The second reference in section (1) has been changed to include the section number as suggested.

COMMENT #2: Joseph F. Rose, with the Missouri Appraisers Advisory Council, noted that subsection (2)(B) reads incorrectly with the word "appraisal" before AMC.

RESPONSE AND EXPLANATION OF CHANGE: The commission agrees that "appraisal" was erroneously left in and should be removed.

COMMENT #3: The commission wished to clarify that an appraiser who has had a credential refused, denied, cancelled, revoked, or surrendered and subsequently has the credential granted or reinstated should then be eligible for hire by an AMC.

RESPONSE AND EXPLANATION OF CHANGE: The commission has amended language in this rule to clarify that an AMC has a system in place to verify that an individual whom the AMC is making an assignment for is not currently on discipline.

#### **20 CSR 2245-10.030 Renewal**

(1) Every license issued shall expire on June 30 of every even numbered year after the date of issuance. The commission shall mail to each registrant, at least sixty (60) days prior to the expiration date of each renewal year, a notice of the expiration and application for renewal of the license to the address on file with the commission. The commission may issue a new registration for each renewal period upon receipt of a properly completed renewal application, nonrefundable fee as established by rule in 20 CSR 2245-5.020(2), and satisfactory proof that the appraisal management company (AMC) meets all requirements for licensure renewal postmarked before midnight on June 30 of

each year of expiration. Delinquent renewals shall be accompanied by a nonrefundable delinquent fee as established by rule in 20 CSR 2245-5.020(2).

(2) At the time of renewal the AMC shall certify to the commission on the renewal form that—

(B) The AMC has a system in place to verify that an individual whom the AMC is making an assignment for the completion of an appraisal does not currently hold a license or certificate on discipline;

**ORDER OF RULEMAKING**

By the authority vested in the Missouri Real Estate Appraisers Commission under section 339.511, RSMo Supp. 2012, and section 339.544, RSMo 2000, the commission adopts a rule as follows:

20 CSR 2245-10.040 is adopted.

A notice of proposed rulemaking containing the text of the proposed rule was published in the *Missouri Register* on December 17, 2012 (37 MoReg 2318–2319). Those sections with changes are reprinted here. This proposed rule becomes effective thirty (30) days after publication in the *Code of State Regulations*.

**SUMMARY OF COMMENTS:** The commission received four (4) comments on the proposed amendment.

**COMMENT #1:** Upon review of the published rules in the *Missouri Register*, the commission discovered that references in sections (2) and (5) should be 330.500 to 339.549 to include all of the applicable statutes.

**RESPONSE AND EXPLANATION OF CHANGE:** The commission has corrected the sections to include the additional statutes.

**COMMENT #2:** Lenore Marema, with The Surety & Fidelity Association of America, noted that the fiscal note incorrectly indicates that a bond would cost between two thousand dollars (\$2,000) and four thousand dollars (\$4,000) a year based on the calculations provided. She states that as a general rule, the cost of a bond will be one-to-two percent (1%–2%) of the bond amount which would be closer to two hundred-to-four hundred dollars (\$200–\$400) annually.

**RESPONSE AND EXPLANATION OF CHANGE:** The commission agrees that the fiscal note shows incorrect calculations, but that the totals are correct. The fiscal note has been corrected to show that a surety bond will cost one-to-two dollars (\$1–\$2) per one hundred dollars (\$100).

**COMMENT #3:** Joseph F. Rose, with the Missouri Appraisers Advisory Council, noted that section (3) reads incorrectly by including the words “appraisal management company” along with the acronym.

**RESPONSE AND EXPLANATION OF CHANGE:** The commission agrees that “appraisal management company” was erroneously left in and should be removed.

**COMMENT #4:** Don Kelly, with Real Estate Valuation Advocacy Association, requested that the language be revised to require thirty-(30-) days advance notice of the cancellation of a bond rather than sixty (60).

**RESPONSE AND EXPLANATION OF CHANGE:** The commission agreed and has revised the language as suggested.

**20 CSR 2245-10.040 Surety Bond Requirements**

(2) The bond shall accrue to the Missouri Real Estate Appraisers Commission for the benefit of a consumer claimant against the AMC to secure the faithful performance of the AMC’s obligations pursuant to sections 339.500 through 339.549, RSMo, and regulations validly promulgated thereunder.

(3) The bond shall be issued by a bonding or insurance company authorized to do business in Missouri and shall secure the faithful performance of the AMC, its employees, or agents in connection with the activities of the AMC.

(5) The surety bond is for the protection of consumers and the commission may make a claim on the bond on behalf of a consumer sustaining injury as a result of the actions of an AMC not in compliance with or in violation of sections 339.500 through 339.549, RSMo.

(7) On receipt by the commission of notice of intent to cancel a bond by a corporate surety, the commission shall immediately notify the AMC that is the principal of the bond of the effective date of the cancellation. The AMC shall provide, from the corporate surety to the commission, no less than thirty (30) days notice prior to cancellation of the bond. Upon notice from the commission of the cancellation of the bond, the AMC shall furnish a like bond before the cancellation date and within seven (7) business days after mailing the notice by the commission. The AMC shall maintain and replace the bond to twenty thousand dollars (\$20,000) after each draw-down and the bond shall remain in effect for the life of the registration and for one (1) year after expiration, revocation, surrender, or cessation of business by the AMC.

*PRIVATE COST: This proposed rule will cost private entities approximately twenty thousand to forty thousand dollars (\$20,000–\$40,000) in the first year of implementation and approximately six hundred to one thousand two hundred dollars (\$600–\$1,200) annually thereafter for the life of the rule. It is anticipated that the costs will recur for the life of the rule, may vary with inflation, and are expected to increase at the rate projected by the Legislative Oversight Committee. The cost for the proposed rule has not changed; however, the method of calculation has been corrected on the fiscal note.*
