EXECUTIVE ORDER 14-16

WHEREAS, the Disparity Study Oversight Review Committee was established by Executive Order 14-07; and

WHEREAS, the Disparity Study Oversight Review Committee was tasked with engaging in a thorough review and analysis of the Disparity Study commissioned by the Office of Administration and developing appropriate recommendations designed to increase the participation of women/minority business enterprises in state contracts; and

WHEREAS, the Disparity Study Oversight Review Committee is required to present a report containing an analysis of the Disparity Study and its recommendations to increase participation by socially and economically disadvantaged small business concerns and women/minority business enterprises in state contracting by December 31, 2014; and

WHEREAS, the Disparity Study Oversight Review Committee has been diligently working on this important effort and has held several public hearings; and

WHEREAS, the Disparity Study Oversight Review Committee has requested additional time to prepare its report and recommendations.



The notice of proposed rulemaking is required to contain an explanation of any new rule or any change in an existing rule and the reasons therefor. This is set out in the Purpose section with each rule. Also required is a citation to the legal authority to make rules. This appears following the text of the rule, after the word "Authority."

ntirely new rules are printed without any special symbology under the heading of proposed rule. If an existing rule is to be amended or rescinded, it will have a heading of proposed amendment or proposed rescission. Rules which are proposed to be amended will have new matter printed in boldface type and matter to be deleted placed in brackets.

n important function of the *Missouri Register* is to solicit and encourage public participation in the rulemaking process. The law provides that for every proposed rule, amendment, or rescission there must be a notice that anyone may comment on the proposed action. This comment may take different forms.

If an agency is required by statute to hold a public hearing before making any new rules, then a Notice of Public Hearing will appear following the text of the rule. Hearing dates must be at least thirty (30) days after publication of the notice in the *Missouri Register*. If no hearing is planned or required, the agency must give a Notice to Submit Comments. This allows anyone to file statements in support of or in opposition to the proposed action with the agency within a specified time, no less than thirty (30) days after publication of the notice in the *Missouri Register*.

n agency may hold a public hearing on a rule even though not required by law to hold one. If an agency allows comments to be received following the hearing date, the close of comments date will be used as the beginning day in the ninety- (90-) day-count necessary for the filing of the order of rulemaking.

If an agency decides to hold a public hearing after planning not to, it must withdraw the earlier notice and file a new notice of proposed rulemaking and schedule a hearing for a date not less than thirty (30) days from the date of publication of the new notice.

Title 19—DEPARTMENT OF HEALTH AND SENIOR SERVICES

Division 15—Division of Senior and Disability Services Chapter 8—Consumer-Directed Services

PROPOSED RULE

19 CSR 15-8.410 Personal Care Attendant Wage Range

PURPOSE: This rule implements a wage range for personal care attendants providing consumer-directed services.

(1) A consumer, in his or her sole discretion, shall set the wage for his or her personal care attendant at an amount within the wage range of eight dollars and fifty cents (\$8.50) to ten dollars and fifteen cents (\$10.15) an hour before taxes, and the vendor shall accept this rate. However, the vendor and consumer may set a wage rate above the wage range by mutual agreement. A personal care attendant who

makes an amount greater than ten dollars and fifteen cents (\$10.15) an hour on the date that this regulation becomes effective shall not have his or her wage rate reduced due to this regulation. In no event shall the wage be set below eight dollars and fifty cents (\$8.50) an hour before taxes. When setting the wage rate, the consumer, as the employer, may consider any job-related factors, including, but not limited to, relevant experience including years of service; applicable education, training, and certifications; past performance and level of consumer satisfaction; and level of care needs of the consumer. When setting the wage rate, the consumer shall convey to the vendor the wage rate on a standardized vendor form and is encouraged to share with the vendor the rationale used to set the wage rate.

(2) For purposes of this regulation, a vendor is any person, firm, or corporation having a written agreement with the department and/or the Missouri Department of Social Services to provide services, including monitoring and oversight of the attendant, orientation and training of the consumer, and fiscal conduit services necessary for delivery of consumer-directed services to physically disabled persons

AUTHORITY: section 208.927, RSMo Supp. 2014. Original rule filed Dec. 26, 2014.

PUBLIC COST: This proposed rule will not cost state agencies or political subdivisions more than five hundred dollars (\$500) in the aggregate.

PRIVATE COST: This proposed rule will cost private entities \$6,952,091-\$43,575,528 annually in the aggregate.

NOTICE TO SUBMIT COMMENTS: Anyone may file a statement in support or in opposition to this proposed rule with the Missouri Department of Health and Senior Services, Division of Senior and Disability Services, Celesta Hartgraves, Director, PO Box 570, Jefferson City, MO, 65102-0570. To be considered, comments must be received within thirty (30) days after publication of this notice in the Missouri Register. No public hearing is scheduled.

IV. ASSUMPTIONS

- The average growth in units of service from Fiscal Year 2010 to Fiscal Year 2014 is 16.77 percent.
- Fiscal Year 2014 actual units of service (81,716,458) were multiplied times the 16.77 percent average growth rate, which yields an estimated 95,420,864 units of service for Fiscal Year 2015.
- The current average wage for personal care attendants is \$8.50 + \$0.89 in taxes (taxes at 10.45 percent) equals \$9.39 per hour, or \$2.35 per 15 minute unit.
- Actual wage data for the individuals involved in delivery of units of service is not available. In order to estimate the fiscal impact of this proposed rule, it is assumed that individuals who deliver services are equally represented in ten-cent wage intervals clustered around the \$8.50 average wage. So the calculation methodology includes ten wage intervals below \$8.50 (starting at \$7.50) and ten wage intervals above \$8.50 (ending at \$9.50).

- It is understood that the wages paid to some individuals are beyond the \$9.50 ceiling employed in the calculation methodology. However, it is assumed that the number of individuals making more than \$9.50 per hour would be relatively small. Also, it is not feasible to calculate the precise amounts absent actual wage data and the number of units provided by individuals at each wage level.
- The analysis assumes that the estimated 95,420,864 units of service are uniformly spread among the individuals at the various 21 wage intervals (\$7.50 through \$9.50).
- The analysis determines the difference between the unit rate for wages and taxes at each of the ten-cent wage intervals versus the unit rate for wages and taxes at the \$8.50 (Scenario 1) and \$10.15 (Scenario 2) salary levels set by the proposed rule.

The order of rulemaking is required to contain a citation to the legal authority upon which the order or rulemaking is based; reference to the date and page or pages where the notice of proposed rulemaking was published in the *Missouri Register*; an explanation of any change between the text of the rule as contained in the notice of proposed rulemaking and the text of the rule as finally adopted, together with the reason for any such change; and the full text of any section or subsection of the rule as adopted which has been changed from that contained in the notice of proposed rulemaking. The effective date of the rule shall be not less than thirty (30) days after the date of publication of the revision to the *Code of State Regulations*.

he agency is also required to make a brief summary of the general nature and extent of comments submitted in support of or opposition to the proposed rule and a concise summary of the testimony presented at the hearing, if any, held in connection with the rulemaking, together with a concise summary of the agency's findings with respect to the merits of any such testimony or comments which are opposed in whole or in part to the proposed rule. RESPONSE: Amendment of the regulatory definition of "good-faith effort" is required to clarify the definition's scope and intent. Specifically, the phrase in the current definition "being eligible to complete and completing the federal need-based aid application" requires clarification. It is MDHE policy that the term "complete" in the definition means the student has provided all of the information required by the FAFSA for federal student aid eligibility. Students with DACA status are unable to accomplish this because they cannot provide the citizenship information required for federal aid eligibility. Since the department believes these students do meet the criteria for state aid eligibility, as defined in section 173.1110, RSMo, the definition must be revised in order to ensure the administrative rule is consistent with statutory provisions by providing a categorical exception for these students.

No changes have been made to the rule as a result of this comment.

COMMENT #2: Jon Hile, Board of Directors Chair, and R. Stephen Green, Ed.D, Superintendent of Schools, Kansas City Public Schools submitted comments supporting the proposed amendment. Their comments indicated the amendment was an important step in helping the Kansas City Public School District achieve its mission of helping all students succeed, that A+ makes college a realistic expectation for students and that it would be shortsighted for a policy to make it more difficult for students to become responsible adults.

RESPONSE: No changes have been made to the rule as a result of this comment.

COMMENT #3: Vanessa Crawford Aragon, Executive Director, Missouri Immigrant and Refugee Advocates (MIRA) submitted comments supporting the proposed amendment as it settles any question regarding DACA grantees' A+ eligibility and ensures Missouri law and regulations reflect federal law. In addition, Ms. Crawford supported the A+ Scholarship's assistance of students granted DACA and indicated these students should be granted access to the scholarship immediately.

RESPONSE: The department agrees that the amendment will bring the A+ regulation into alignment with state law. However, the amendment of the rule is necessary to accomplish that for the reasons given in the response to Comment 1.

No changes have been made to the rule as a result of this comment.

COMMENT #4: Faith Sandler, Executive Director, Karissa Anderson, Senior Policy Intern, and Sidney Goldstein, Board of Directors of the Scholarship Foundation of St. Louis submitted comments supporting the proposed amendment, but opposing the practice of charging students granted DACA international or non-residential tuition rates. They indicated the proposed amendment is an important step to furthering educational opportunity in Missouri and ensures consistent program administration in conformity with the law. In addition, they urge the department to grant immediate A+benefits to students granted DACA.

RESPONSE: The department agrees with the positive impacts of the A+ Scholarship and the need to align the administrative rule with state statutes. However, the amendment of the rule is necessary to accomplish that for the reasons given in the response to Comment 1.

The department defers response to the opposition to the practice of charging students granted DACA international or non-residential tuition rates as that issue is outside the scope of the proposed amendment.

No changes have been made to the rule as a result of this comment.

COMMENT #5: Jane Donahue, Co-Chair, and Faith Sandler, Co-Chair, of the Advocacy Committee of St. Louis Graduates submitted comments supporting the proposed amendment as it settles any question regarding DACA grantees' A+ eligibility and aligns departmental practices with existing law. In addition, Ms. Donahue and Ms. Sandler urged the department to grant immediate A+ benefits to students granted DACA.

RESPONSE: The department agrees that the amendment will bring the A+ regulation into alignment with existing law. However, the department cannot grant the students granted DACA immediate access to the scholarship because of the reasons given in response to Comment 1.

No changes have been made to the rule as a result of this comment.

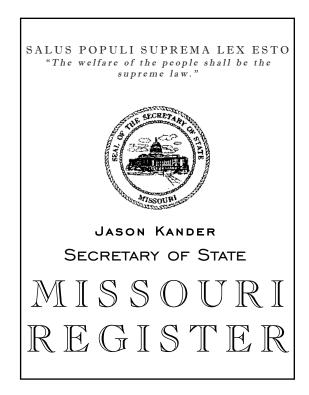
