

It is a class A misdemeanor punishable, notwithstanding the provisions of section 560.021, RSMo, to the contrary, for a term of imprisonment not to exceed one year in the county jail or a fine not to exceed ten thousand dollars or both, for anyone to sign any initiative petition with any name other than his or her own, or knowingly to sign his or her name more than once for the same measure for the same election, or to sign a petition when such person knows he or she is not a registered voter.

Be it resolved by the people of the state of Missouri that the Constitution be amended:

Article IV of the Constitution is revised by adding one new section to be known as section 30(e) of Article IV to read as follows:

Section 30(e). 1. Neither the General Assembly nor any other entity or officer of state government may finance, acquire, construct, maintain, improve, reconstruct, or operate toll roads or toll facilities in this state.

2. "Toll facility" includes any facility, structure, or appurtenance which is to be paid for in whole or in part from revenues collected from tolls, fees, rents, or other charges imposed for the use of the facility.

3. The state may not relocate or incorporate any public roads, highways, or bridges into a toll facility project.

4. The state may not transfer all or part of a public road, highway, or bridge to another entity for operation as a toll road or toll facility.

5. Nothing herein shall prevent the collection of taxes for the benefit of the state transportation fund.
