## BE IT RESOLVED BY THE PEOPLE of the state of Missouri that the Constitution be amended:

Article IV, Section 48 is amended by adding one new section known as 48(a), to read as follows:

No person operating a moving motor vehicle upon the highways of this state shall, by means of a hand-held electronic wireless communications device, make or take part in a phone call, or send, read, or write a text message or electronic message, unless the device is equipped with technology allowing for hands-free operation or equipped for voice-re cognition hands-free texting and is being used in such manner. 2. Except as otherwise provided in this section, no person shall operate a commercial motor vehicle while using a hand-held mobile telephone. 3. Except as otherwise provided in this section, no person shall operate a commercial motor vehicle while using a wireless communications device to send, read, or write a text message or electronic message. 4. The provisions of subsection 1 through subsection 3 of this section shall not apply to a person operating: (1) An authorized emergency vehicle.
