It is a class A misdemeanor punishable, notwithstanding the provisions of section 560.021, RSMo, to the contrary, for a term of imprisonment not to exceed one year in the county jail or a fine not to exceed ten thousand dollars or both, for anyone to sign any initiative petition with any name other than his or her own, or knowingly to sign his or her name more than once for the same measure for the same election, or to sign a petition when such person knows he or she is not a registered voter.

Be it resolved by the people of the state of Missouri that the Constitution be amended:

Article I is amended by adding and adopting one new section to be known as Section 36.

Section 36. The jury or judge as the trier of the facts in civil actions or torts shall not be limited in their judgment to award a claimant with standing any and all damages that the jury or judge that renders judgement may deem fair and just. Nor shall the trier of the facts be limited in factors to be considered in calculation of damages, including but not limited to any such factors as pain, suffering, grief, or bereavement.
