It is a class A misdemeanor punishable, notwithstanding the provisions of section 560.021, RSMo, to the contrary, for a term of imprisonment not to exceed one year in the county jail or a fine not to exceed ten thousand dollars or both, for anyone to sign any initiative petition with any name other than his or her own, or knowingly to sign his or her name more than once for the same measure for the same election, or to sign a petition when such person knows he or she is not a registered voter.

*Be it resolved by the people of the state of Missouri that the Constitution be amended:*

Article XII is amended by adding and adopting one new section to be known as Section 2(c).

Section 2(c). Any amendment adopted or section added and adopted to this Constitution by ballot affirmation of the voters of the State of Missouri through a voter petition amendment process shall only be amended or repealed in same manner as was performed to ratify such amendment or section.
