**5 CSR 50-321.020 General Provisions Gov-  
erning the Consolidated Grants for the  
Federal and State Discretionary Programs**

*PURPOSE:* The Department of Elementary and Secondary Education has the responsibility to disburse funds under a variety of discretionary programs. Funds support a variety of purposes including local reform, homeless children and youth, family literacy, language assistance, and immigrant children.

*PUBLISHER'S NOTE:* The publication of the full text of the material that the adopting agency has incorporated by reference in this rule would be unduly cumbersome or expensive.
