Though its functions date back to 1847, the Missouri Department of Mental Health was first established as a cabinet-level state agency by the Omnibus State Government Reorganization Act, effective July 1, 1974.

State law provides three principal missions for the department: (1) the prevention of mental disorders, developmental disabilities and substance abuse; (2) the treatment, habilitation and rehabilitation of Missourians with those conditions; and (3) the improvement of public understanding and attitudes about mental disorders, developmental disabilities and substance abuse.

The vision of the Department of Mental Health is one of "Lives Beyond Limitations." The vision is that Missourians shall be free to live their lives and pursue their dreams beyond the limitations of mental illness, developmental disabilities, alcohol and other drug abuse.

Missourians must know that mental illness is a treatable disease, persons with substance abuse problems can triumph over their addictions, and persons with developmental disabilities can be productive citizens and good neighbors in their communities.

Mental Health Commission

The commission, composed of seven members, appoints the director of the Department of Mental Health with confirmation of the Senate. Commissioners are appointed to four-year terms by the governor, again with the confirmation of the Senate. The commissioners serve as policy advisers to the department director.

The commission, by law, must include an advocate of community mental health services, a physician who is an expert in the treatment of mental illness, a physician concerned with developmental disabilities, a member with business expertise, an advocate of substance abuse

Office of the Director

With advice from the Mental Health Commission, the director is responsible for overall operations of the department, its three operating divisions, five support offices, 28 facilities and central office. The director's duties include planning, supervising and evaluating the provision of services for Missourians with mental disorders, developmental disabilities and substance abuse.

Each year the department provides services to more than 100,000 Missourians through the Division of Comprehensive Psychiatric Services, the Division of Mental Retardation and Developmental Disabilities and the Division of Alcohol and Drug Abuse.

The **Office of Administration**, headed by the department's deputy director for administration, provides a range of administrative and financial services to help the department achieve effective results. Services provided by the Office of Administration can be divided into the following areas: fiscal management accounts for all funds, manages expenditures, and produces fiscal sum-

maries, analyses, and reports; capital improvements and general services provide technical assistance on construction, maintenance and repair for 28 state-owned facilities, and coordinates leases; contracts and procurement manages more than 4,000 contracts with private agencies or individuals to provide services in the community; reimbursements collects payments from private insurance, Medicaid and Medicare, and private pay for department services and coordinates revenue maximization proposals; budget services develops and monitors the annual operating and leasing budgets and oversees spending plans; and dietetic services manages national school lunch and commodity programs and provides technical assistance in food management and nutrition in department facilities.

The **Office of Consumer Affairs** provides consumer and family views in policy making, aids in accessing services and ensures that client rights are protected.

The **Office of Quality Management** is currently responsible for a myriad of department-wide and statewide functions in support of the Department Director's Office, the three clinical divisions and the other department support offices. These functions serve to coordinate and

implement quality processes to enhance division services to consumers through the following mechanisms:

- Survey, licensure and certification of facilities and treatment programs, including technical assistance;
- Technical assistance to, and staff support of, major federal and state initiatives such as HIPAA compliance and Nursing Home Reform;
- Internal and external audit services, related to compliance, financial, and performance reviews;
- Abuse and neglect investigations and associated technical assistance for local investigations;
- Direction and coordination of CQI and outcomes evaluation processes, including annual customer satisfaction survey, web based reporting of results and other DMH outcome/performance based data collection and reporting;
- Appeals and hearings for administrative due process;
- Coordination of the department's regulatory and records management processes;
- Department-wide HIPAA (Health Insurance Portability and Accountability Act) privacy administration and coordination;
- Medical/clinical quality assurance and health care policy consultation to the department's management and facility operations;
- Coordination of the department's strategic planning process.

The **Office of Human Resources** (OHR) coordinates department-wide personnel, labor relations, and other related functions including collective bargaining and union contract administration; compensation management; personnel policy development, implementation and interpretation; grievance administration; employee data collection and analysis; compliance with state and federal rules, regulations and statutes; and, consultation to local facility human resources offices. The OHR also maintains the department's employment disqualification list and processes employee background screenings. In addition, the OHR provides administrative support in personnel and human resources for the department's central office including recruitment, compensation, timekeeping, recordkeeping, and other employment processing activities and advises department management on policy decisions.

The **Office of Information Systems** is responsible for identifying, implementing, and maintaining information and communication systems

that improve the effectiveness of the Department of Mental Health.

The **Office of Public Affairs** is responsible for coordinating the department's public education efforts regarding mental health issues. Office staff develops and disseminates informational materials and helps to keep providers, consumers and the public informed of mental health programs, services and issues. The office also provides informational updates, support services, technical assistance and communications training to staff in the department's divisions, offices and facilities.

Division of Alcohol and Drug Abuse

The Division of Alcohol and Drug Abuse was established within the Department of Mental Health in 1975, and became a statutory entity in 1980 with the passage of the Omnibus Mental Health Act.

The division is responsible for assuring that treatment and prevention services are accessible to persons with substance abuse and gambling disorders, and to those at risk for such disorders. In Missouri, over 378,000 adults and 114,000 adolescents need some form of intervention for

alcohol and other drug abuse. They cost the state's economy an estimated \$6.9 billion a year. Studies have shown that every dollar spent on substance abuse treatment saves \$12 in state and federal expenditures due to lost productivity, crime, traffic accidents, medical care, and other social costs.

The division meets its responsibilities for comprehensive treatment and prevention services through a network of contracted community-based providers and state-operated facilities. The division's administrative responsibilities include management of state and federal funds for substance abuse treatment and prevention services, contract monitoring, technical assistance and training, development of standards of care, research, dissemination of public information, clinical utilization review, management of the Substance Abuse Traffic Offender Program (SATOP), and oversight of Comprehensive Substance Abuse Treatment and Rehabilitation (CSTAR), the state's Medicaid program for substance abuse treatment for adolescents, pregnant women, women with children, and other adults.

Division of Comprehensive Psychiatric Services

The Division of Comprehensive Psychiatric Services provides inpatient and residential services for children and adults at eleven (11) state-operated facilities. These include four long-term care facilities, three acute care hospitals, one facility with both acute and long-term services, one sexual offender treatment center, one chil-

dren's psychiatric hospital, and one children's residential treatment center.

In addition, the division contracts with not-for-profit community mental health centers to provide services for persons with mental illness in each of 25 geographic service areas. The agency responsible for service provision in each service area is designated as the division's administrative agent. The administrative agents are responsible for assessment and service delivery to eligible individuals in their geographic service area. This includes responsibility to provide follow-up services to persons who have been discharged from state-operated inpatient services. Children and their families are also served by administrative agents.

Supported community living programs are provided to individuals with mental illness who require financial subsidies to support their housing needs or need more structured services to live in the community. Living arrangements in this program range from nursing homes to apartments and other settings that are integrated into the community. Persons in these programs are provided support through case management and community psychiatric rehabilitation program services provided by administrative agents.

During fiscal year 2002, the division provided:

- inpatient services to 7,763 adults and 811 children;
- outpatient and community support to 50,134 adults and 12,438 children; and
- supported community living services to 7,103 adults and 397 children.

The State Advisory Council for Comprehensive Psychiatric Services

The State Advisory Council for Comprehensive Psychiatric Services was first established in 1977 by the governor's executive order. Members are appointed by the director of the Division of

Comprehensive Psychiatric Services. The council is comprised of 25 members who advise and make recommendations on the development and coordination of a statewide inter-agency/inter-departmental system of care for children/youth with serious emotional disorders and persons with mental illness and their families. Through public education and advocacy efforts consumers of mental health services and their families have become an integral part of defining priorities for the division on issues surrounding accessible services, crisis intervention, children's services, recovery and budget. The council works with other mental health advocacy groups in planning and coordinating Mental Health Awareness Day, an event that brings together consumers, family members, mental health professionals and advocates throughout the state where they participate at the Capitol in educational seminars, media awards, and a rally to promote advocacy.

Fulton State Hospital, authorized in 1847 and opened in 1851, is the oldest public mental health facility west of the Mississippi River. The 505-bed hospital provides inpatient adult psychiatric services, including long-term care, for a 31-county area in the state's northeast quadrant.

The hospital has been accredited by the Joint Commission on Accreditation of Healthcare

Organizations since 1984. It has 21 beds certified for federal Medicaid or Medicare reimbursement.

The 64-bed Adult Psychiatric Center offers psychosocial rehabilitation services for long-term care patients. The hospital also operates a 24-bed group home complex on its grounds.

Fulton has Missouri's only maximum-security and intermediate-security settings for persons committed by the circuit courts for psychiatric treatment. The 216-bed Biggs Forensic Center provides treatment for those committed as not guilty by reason of mental disease or defect (NGRI) as well as pre-trial evaluations for those who require a maximum security setting. Also in Biggs is a cooperative treatment program with the Department of Corrections (DOC) providing acute mental health care for inmates from DOC. The 175-bed Guhleman Forensic Center offers an intermediate security environment that allows former Biggs patients to progress toward increased liberty and responsibility.

The hospital has a training affiliation with the University of Missouri School of Medicine's Psychiatry Department. The hospital provides clinical experience to various student programs, including students from surrounding schools of nursing, social work programs, occupational therapy programs, and psychology training programs.

Hawthorn Children's Psychiatric Hospital provides inpatient psychiatric services for severely emotionally disturbed children and adolescents, ages 6 to 17. The hospital serves the 31 counties of eastern and southeastern Missouri.

Hawthorn has been a free-standing child psychiatric facility in St. Louis County since 1989. The hospital is accredited by the Joint Commission on Accreditation of Health Care Organizations and certified for federal Medicaid reimbursement.

The 26 acre campus consists of a main building and five cottages which can house 60 psychiatric treatment beds. Hawthorn currently maintains 28 inpatient and 24 residential treatment beds. The hospital also operates a cooperative day treatment program providing psycho-educational services for 16 students in conjunction with the Special School District of St. Louis County.

Youth are assessed and provided comprehensive services addressing their psychiatric, psychological, social, educational, vocational and recreational needs. Diagnostic and treatment services are available for the juvenile courts.

Hawthorn has a training affiliation with the Psychiatry Department of the Washington University School of Medicine. The hospital also provides clinical experience to various student training programs, including the disciplines of social work, dietary, nursing and psychology.

The center operates an emergency room that provides screening, evaluation, crisis intervention, referral and admission. A clinical research program, staffed by psychiatrists from Washington University, is well established at that facility. Community education and consultation are provided by the staff of the facility as part of its effort toward the prevention of mental illness.

MPC is accredited by the Joint Commission on Accreditation of Healthcare Organizations and eligible for reimbursement under the Medicare and Medicaid programs. The center has a long and valued history as a site for professional education. In affiliation with Washington University School of Medicine, training is provided for psychiatric residents. With a consortium of other providers, MPC is nationally recognized for a clinical psychology pre-doctoral internship program. Other professions receiving training at MPC include social work, occupational therapy and nursing.

The staff of the center provides a variety of intensive psychosocial rehabilitation programs that facilitate a return to independent living within the community, while preserving public safety.

Southeast Missouri Mental Health Center began in 1903 as Farmington State Hospital. In 1984, the Missouri General Assembly approved the conversion of most of the hospital into a medium-security prison, operated by the Department of Corrections. Subsequently in 1987, the state hospital was converted into a mental health center and moved into buildings adjacent to the prison.

The 208-bed psychiatric center provides acute and intermediate treatment for a 31-county catchment area, and maintains a 90-bed minimum/campus-security, forensic unit for patients referred by the criminal courts for psychiatric evaluation and/or treatment.

By cooperative agreement with the Department of Corrections and Mental Health, the Corrections Treatment Center (CTC) was established and operates on the grounds of Farmington Correctional Center. Within this unit, the mental health center staffs a small medium-security ward for inmates with psychiatric needs, and provides psychiatric coverage, case manage-

ment and medication services for a 200-bed social rehabilitation unit.

In December, 1997, Southwest Missouri Psychiatric Rehabilitation Center (SWMPRC) formerly Southwest Missouri Mental Health Center, moved into a new facility in El Dorado Springs from its previous location in Nevada. The 30-bed, adult psychiatric treatment facility provides both acute and long-term care for Service Area 8, and long-term backup care for Service Area 9 and 10. The three Service Areas are located in

the CPS Southwest Region, consisting of 21 counties in Southwest Missouri.

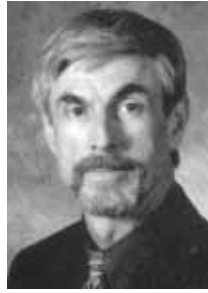
The Administrative Agents are the entry and exit points for all DMH funded psychiatric services in the Southwest Region. Each Administrative Agent manages admissions to assigned beds at Southwest Missouri Psychiatric Rehabilitation Center based upon percentage of population. The facility accepts those persons in need of treatment for serious mental illness and mental disorders. The staff of the facility provides intensive psychosocial rehabilitation treatment, which facilitates a return to living in the community. Administrative Agent staff are involved with the treatment process and discharge planning by attending a monthly patient review meeting at the facility. Housing Support Services are also provided to clients residing in the Regional Supported Housing Program located in Nevada and El Dorado Springs.

Following discharge, community-based care and treatment is provided by staff of the Administrative Agents through the POS Program, the decentralized community placement program, and the Medicaid-funded targeted case management and CPRC programs. Treatment services are monitored by the staff of the Southwest Regional Supported Community Living Program, located in Nevada.

The Missouri Sexual Offender Treatment Center provides appropriate treatment, care, security and custody for those persons adjudicated as sexually violent predators. With the passage of the Sexually Violent Predator law, which was effective January 1, 1999, the Missouri General Assembly mandated that those individuals adjudicated by the court as “sexually violent predators” be committed indefinitely to the custody of the Director of the Department of Mental Health for “control, care and treatment until such time...that the person is safe to be at large.” In order for such commitments to pass constitutional scrutiny, the department provides care and treatment that is consistent with existing professional standards and practice. The law also requires that individuals committed for treatment as sexually violent predators be kept in a security facility and housed separately from Department of Corrections inmates and from persons served by the Department of Mental Health who have not been found to be sexually violent predators.

The location and treatment of sexually violent predators is on the campus shared by Missouri Sexual Offender Treatment Center, Southeast Missouri Mental Health Center, and Farmington Correctional Center, in Farmington. Currently in the facility there are 39 individuals committed for treatment, with 31 individuals detained who are in the commitment review process. Projections suggest that 17-25 individuals will be referred to the program for detention and evaluation each year. It is anticipated for the initial years of operation, the commitments to the center will greatly exceed court ordered releases.

In addition to the treatment and custody of sexually violent predators, the department is required to provide staff to participate in the multidisciplinary team to assist the Prosecutor’s Review Committee in determining whether an individual may meet the definition of a sexually violent predator. Further, the department is required to evaluate each individual for whom the court finds probable cause to believe the person is a sexually violent predator. Finally, the department must annually provide the committing court an annual report regarding the committed person’s mental condition.

Division of Mental Retardation and Developmental Disabilities

The Division of Mental Retardation and Developmental Disabilities, established in 1974, serves a population that has developmental disabilities such as mental retardation, cerebral palsy, head injury, autism, epilepsy and certain learning disabilities. Such conditions must have occurred before age 22 and are likely to continue indefinitely. To be eligible for services from the division, persons with these disabilities must be substantially limited in their ability to function independently.

The division improves the lives of persons with developmental disabilities through supports and services to enable those persons to live independently and productively. In 1988, the division began participation in the Medicaid Home and Community Based Waiver program, designed to help expand needed services throughout the state.

The division operates 17 facilities that provide or purchase specialized services. The 11 regional centers form the framework for the system and are backed by six habilitation centers that provide residential care and habilitation services for more severely disabled persons.

The regional centers, the primary points of entry into the system, provide assessment and case management services that include coordination of each eligible person's individualized plan.

Referrals may be made by a regional center to a habilitation center. Habilitation centers primarily serve persons who are severely disabled, behaviorally disordered, court-committed or medically fragile. All habilitation centers are Medicaid certified.

State and Regional Planning and Advisory Councils

The division receives consumer advice and planning assistance from the Missouri Planning Council for Developmental Disabilities and 11 regional councils. The regional council's members are drawn from areas served by the regional centers.

The Missouri Planning Council for Developmental Disabilities was created in 1971 under federal legislation. The council also serves, under Missouri statute, as the State Advisory Council on Mental Retardation and Developmental Disabilities, providing advice to the division director and other state agencies that serve persons with developmental disabilities.

Missouri Planning Council members are appointed by the governor. The council develops
